We the Oneida Nation do hereby acknowledge to have receives from the State of New York the sum of Five thousand and hundred and sixty nine dollars and twenty eight cents in full for the several annuities which became due to the Oneida Nation and the 1st day of June instant according to the stipulators mentioned and contained in three certain agreements made with the said Oneida Nation by certain Agents or Commissioners on the part of the said State: The one bearing date the fifteenth day of September in the year of our lord one thousand seven hundred and ninety five, the second bearing date the first day of June in the year of our Lord one thousand seven hundred and ninety eight, and the third bearing the date the fourth day of June in the year of our Lord one thousand eight hundred two.
