Feb. 5, 1931 The Six-Nation Treaty

The realization of the peace and friendship hereby established and of the engagements entered into by the Six Nations and because the United States desires, with humanity and kindness, to contribute to their comfortable support, and to promote the peace and friendship hereby established, strong and perpetual; the United States now delivers to the Six Nations, and the Indians of the other nations residing among and united with them, a quantity of goods of no value of ten thousand dollars. And for the same consideration and with a view to promote the future welfare of the Six Nations and of their Indian friends aforesaid, the United States will give the sum of three thousand dollars to the one thousand five hundred dollars, hereafter allowed them by an article entitled by the President on the twenty-third day of April, 1792, making in the whole, four thousand five hundred dollars; which shall be expended yearly forever, in purchasing clothing, domestic animals, implements of husbandry, and other utensils suited to their circumstances, and in compensating useful artificers, who shall reside with or near them, and be employed for their benefit. The immediate application of the whole allowance now stipulated to be made by the superintendent appointed by the President for the affairs of the Six Nations, and their Indian friends aforesaid.

This is Article V of the United States-Six Nations Treaty of November 11, 1794 (7 Stat. 44). The liquidation of the financial provision of this treaty is currently causing much publicity and to which I wish to comment briefly.

The preamble to this treaty - (I quote one - reads: "The President - George Washington - of the United States having determined to hold a conference with the Six Nations of Indians, for the purpose of removing from their minds all causes of complaint, and establishing a firm and permanent friendship with them, etc." Like all good citizens of the United States, the Onondaga people honor the memory of George Washington and desire to preserve his works.

The \$60,000 estimate is misconstrued by many as a proposal by the commissioner of Indian Affairs in his letter to the Onondaga. As a matter of fact, it is merely a suggestion. The object of the letter was what can be done about a settlement?

On the occasion of the first visit of ten Indian Office officials, the executive committee members invited any interested parties to the conference. At this conference all registered objections to the settlement.

The members of the Executive Committee, yielding to their senses of fairness, elected to submit the question to the tribal council. Again no one called for a settlement. However the meeting was maneuvered into postponing final action on the question.

At a regular tribal council on December 31st a postponement again was achieved to February
