Dear sir,

This is response to your recent television appearance at which you expressed the possibility of cross deputizing the Oneida Security Officers thereby giving them full police powers and arresting authority. Many of us Oneidas see this move as unwise due to the internal political problems involved.

The Oneida Tribal Council is the governing body of the Oneida Tribe. By Constitution the Tribal Council established the Business Committee granting it limited powers to attend to the day to day functions of the Tribe. There is a tendency from time to time for the Business Committee to act beyond it's Constitutional authority or not to act on issues within it' authority. Issues outside of the Business Committee's authority are to be brought before the General Tribal Council for approval. (The General Tribal Council is comprised of the voting membership of the Tribe.) This did not happen in the case of the Oneida Security program. The majority of us believe that until the Business Committee presents the proposal for a security program to the General Council and it is approved, there is no legal security system in force. (Emphasis added).

Secondly, on two occasions in the not too distant past a proposal came before the General Council to establish a Tribal Court. The issue was voted down on both occasions. We see this issue of the security system as an attempt at coming in the back door to force a Tribal Court system upon us. The majority of the Oneida membership are very reluctant to subjecting ourselves to yet another layer of government.

Should the issue of the security system be properly brought before the General Council and approved, their duties should be restricted to night-watch duties over the Tribal enterprises and elderly facilities and security at the Hotel. Nothing else.

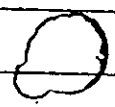
