



POWLESS - HILL RE-ELECTED

After a record turnout of voters for the 1987 Tribal Election, incumbent Purcell Powless regained his position as Chairman in a landslide victory over challengers Shirley Hill and Art Skenandore Jr.

Others who were re-elected to the 9 member Business Committee were Vice Chairman Rick Hill who was victorius over candidates, Carlton Smith and Charles Wheelock, additionally Kathy Hughes regained the Treasurer's position over challenger Wendell McLester. Councilman's positions that were regained were top vote getter David "Sonny" King and Lloyd Powless.


Newly elected tribal members to the council were Amelia Cornelius who regained the position of Tribal Secretary that she held in 1978.

Other candidates elected to the Oneida Trust Committee were Pearl McLester, Anna John, and Vera Wilson. The newly elected school board members are Marj Stevens, Jerry L. Hill, and Ron Hill.

The new Business Committee members take over their positions on August 24, 1987 at the General Tribal Council Meeting held at 7 pm at the Norbert Hill Center.

Stevens campaign stressed the promotion of economic stability on the reservation, to rechannel tribal monies back to the reservation.







Oneida Man Honored At State Fair

Oneida Tribal Elder Amos Christjohn has been honored as one of the 1987 Ten Most Admired Senior Citizens in Wisconsin. The honor was presented during ceremonies in Milwaukee last Thursday evening.

Christjohn, who is known as the "Keeper of the Oneida Language", received an elaborate plaque from Security Savings and Loan Association of Milwaukee and the Wisconsin State Fair, sponsors of the contest. June Tyler of Green Bay and Frank Buettner of Shawano, were also honored at the banquet held at the Marriott Hotel.

Friday, Christjohn and the other winners were treated to a day of activities at the Wisconsin State Fair. They attended Fair activities, including the Senior Talent Show, craft demonstrations and displays.

They also participated in the "High Stepping" Dance Contest and were introduced to the audience at the Grandstand Show, where they had reserved seats. During the afternoon, Amos and the other winners took part in a parade through the fairgrounds. Each rode in a special automobile.

The day ended with a buffet supper and refreshments at the Marriott.

Amos was nominated for the annual award by Oneida Tribal Chairman Purcell Powless. In his letter of nomination, Powless cited the 79 year old Christjohn for being "truly dedicated to the preservation of the Oneida Language and culture, and the traditions of our people in the most unselfish way."

Bingo Skimming Update to General Tribal Council

On January 28, 1987 information was received through the mail addressed to Oneida Tribal Bingo Hall, informing the recipients that there was the informant and six others that knew of exchanges involving, "tickets for dope". At that point a daily reconciliation of Bingo receipts was done and shortages were discovered. After a review by the Oneida Public Safety Department and Oneida Tribal Attorney Francis Skenandore of the information provided by Bingo personnel it was determined a federal crime had been committed, and it was necessary to contact the FBI. On February 16, the FBI was contacted and the first meeting with them took place the following day. That meeting resulted in a decision to conduct a joint investigation. Following a meeting with the Oneida Business Committee on February 23, 1987, it was decided on February 25th, that there was a necessity to hold a press conference to release information about the skimming. On February 27th, a press conference was held with the local TV stations and newspapers. The press conference was held by Chief Jim Danforth and Attorney Francis Skenandore at the Norbert Hill Center in Oneida.

On March 3, it was approved by the Oneida Business Committee to have an audit conducted by a local Green Bay firm, Wipfli-Ulrich.

Once again on March 20th, they met with the auditors because of information pertaining to free bingo passes. This information prompted further investigation of records surrounding the dissemination of free passes. On April 3, 1987 the Oneida Business Committee directed that no free passes be issued unless approved by the Oneida Business Committee.

Initially it was decided to set some objectives in pursuing this investigation. The following are those objectives:

- 1. That a preliminary determination be made as to the amounts and how long the shortage had occurred.
- 2. There was a need to determine what persons were possibly involved.
- 3. That the shortage must be stopped immediately.

- 4. An audit was recommended to determine exact losses.
- 5. Attempt to bring charges against individuals involved.
- 6. Immediate implementation of stricter controls in the pull-tab areas to stop the skimming.
- 7. That a management review be done.

On May 5, 1987 the investigation was completed and forwarded to the United States Attorney Gerneral, Francis Schmidt (U.S.A.G. Schmidt) of Milwaukee for a review and determination of what charges would be filed against individuals involved. At the time of the semi-annual July 6th General Tribal Council meeting, some individuals involved had been sent letters requesting them or their attorneys to contact the U.S.A.G. Schmidt by July 8, 1987. If these individuals did not make contact by the date stipulated in the letter, they would become subject to possible indictment by a grand jury. Two individuals have contacted the U.S.A.G. Schmidt in Milwaukee.

To date, no formal charges have been filed. There is a possibility, still under investigation that a tribal member off the reservation could be connected to the Bingo skimming.

Other information pertaining to the abuse of free bingo passes is still under investigation by the Oneida Law Department and the Oneida Public Safety Department. At this time this information is being reviewed. The abuse of free bingo passes is considered peripheral information that does not directly affect the pull-tab investigation.

The Conservation Board will be holding a regular meeting to update the public on their duties, concerns, and projects. Your ideas and input will be appreciated.

The Hunter Safety certification for 12-16 year olds will be strictly enforced this year. All must comply if they intend to hunt within the reservation boundaries. All hunters should be aware that sportsmans permits will not be issued without a hunter safety certificate. This coincides with the state law which is also mandatory.

Hunter Saftey Classes will be set up with a minimum of 7 registrations. Interested persons should call 869-1420 or leave a message in the Public Safety Office - 869-2345.


This month a new WCC crew will start working on the reservation.



Employee TB Screening:

The Community Health Department will offer two TB Screening clinics each month in order to accommodate the employee screening requirement. One will be offered at the Norbert Hill Center, and one will be offered at Bingo.

We will administer the skin test the first day at each site, and two days later we will be back to read the skin test. If you cannot return on the second day to have the skin test read, it will not be recorded, and you will need to have the test repeated. Skin tests are also available on the walk-in basis through the Community Health Nursing Department --- we do suggest that you call first.

MISDIRECTED BILLS FROM HOSPITALS

As you may or may not be aware, not all processing of lab tests that you have blood drawn for are done here in the Health Center's laboratory ... more complicated tests are done at one of the local Green Bay hospitals.

Every now and then, the hospital errors by sending the bill to you (the patient) instead of sending it to us. Simply mail or drop off the bill here at the Health Center and Contract Health Services will take care of it. (Remember, CHS will cover these bills only on lab sent out from the Health Center; if you have your blood drawn for testing at some other clinic, by your own choice, the bill for those services is your responsibility.)

CONTRACT HEALTH SERVICES

Contract Health Services are provided to eligible patients when referred by a Health Center Doctor. Contract Health funds will not be used to provide services which are available at the Oneida Health Center.

All available resources must be exhausted before Contract Health Services can be utilized. If you have insurance or Medicare, please inform the Contract Health Department when payments are made, so that we can pay the balance on your referral. We cannot pay co-payments for Medical Assistance or balances that (MA) Med. Asst. does not pay. (If you are on (MA) Medical Assistance, PLEASE present your card for ALL services.)

In case of an emergency situation, you must call one of our providers at the Health Center: the number is 869-2711. If you are unable to contact someone before going to the Emergency Room, you must contact the Contract Health Department within 48-72 hours, or YOU WILL BE RESPONSIBLE FOR ANY BILLING related to your Emergency Room care.

St. Mary's Hospital is the only hospital which the Health Center Doctors can provide emergency care should there be a need to use the Emergency Room. If you go to another hospital for these services, YOU WILL BE RESPONSIBLE FOR THE BILL ALSO. If you have any questions on any of the above, please call Wanda or Patti, at Ext. 227 (869-2711) Oneida Health Center.

TO WHOM IT MAY CONCERN.... (OPTICAL)

The Optical Dept. at the Health Center had identified a large number of glasses that have been ordered as prescribed, but not picked up or paid. The intent of this notice is to advise you that if you have ordered glasses, you will be contacted to either pick up and pay, or make arrangements for such. There will be a **90 day waiting period** after which we will be returning your order to recover OUR cost on the frames. Your glasses will no longer be available except on a reorder/pre-paying basis. (A second pair of glasses will NOT be issued until the cost of the first pair is recovered.)

Also, we know that most insurances don't include coverage for optical needs (glasses) but encourage you to look over your insurance policy to assure yourself that possible coverage doesn't exist. Some companies pay for "safety" glass lens for their employees. Check it out with your employer! Thanks for your past cooperation and your future patience and understanding.


COMPETITION POW-WOW - Friday evening will be the start of the competition Pow-wow.

REQUIREMENTS FOR BLOOD DONORS

You must be in good health, weigh at least 110 pounds, and should have regular, nutritious meals on the day you donate. Anyone between the ages of 17 and 71 may be a donor.

ON THE DAY OF YOUR DONATION

SYMPTOMS OF DISEASE:

No colds, sore throat or flu symptoms. You should be free from skin infections, boils and active allergies on the day of your

donation.

MEDICATIONS:

Permitted without restrictions: Vitamins, oral contraceptives, hormones, mild tranquilizers. Tetracycline is also permitted when used for skin problems. Thyroid and gout medication are permissible in most cases.

For other prescription and non-prescription drugs, check with The Community Blood Center a week before donating.

TEMPORARY RESTRICTIONS:

There is an **eight week** waiting period between blood donations. Female donors may not be pregnant on the day of donation and must wait six weeks following the end of pregnancy.

There is a **six month** waiting period following: Major surgery, after receiving a blood transfusion, after being tattooed, after returning from a malarious area, or following contact with viral hepatitis (12 month wait if you received gamma globulin).

A borderline diabetic may donate if on oral medication with the disease under control.

PERMANENT DEFERRAL:

You **cannot give blood** if you have viral hepatitis, epilepsy, diabetes, some forms of heart disease and most forms of cancer.

AIDS: The following individuals may not donate blood. Anyone having AIDS. Any past or present abusers of intravenous (IV) drugs, any male who has had sex with another male since 1977. This includes even individuals who have had only a single homosexual experience. Haitians who have entered the U.S. after 1977. Patients with hemophilia. Sexual partners of individuals in any of the above categories.

Seymour School District The Pace Program

PACE is an alternative education program in the Seymour School District. The 3 broad goals of the PACE Program are: Personal, to develop positive mental attitudes toward self, others, schoolwork and life; Academic, to develop basic skills of communication, computation and logic to make decisions and solve problems; and Career, to develop the confidence and desire to acquire skills necessary for employment.

The programs driving force is the student who will develop the ability to solve problems, make decisions, self control, self awareness and personal responsibility for his/her actions in all areas of life.

Students in the PACE Program are in school part of the day and work outside the school for part of the day. The student is required to complete school work and tasks assigned to them on the job site.

Vehicles were checked to determine if oil changes/tune-ups were due and if so, they were completed. Chuck also was involved extensively in automotive detailing. American Indian Graduate Students


The University of California, Berkeley, has announced the opportunity of financial aid available to qualifying American Indian students in the graduate field of Public Health.

The students are learning to gain hands on experience by using telecommunication equipment, such as cameras, microphones, sound monitors and editing boards.

The program is mainly to teach the students to become good communicators within their group, understand the responsibilities, and to be able to explain their project to others.

By the end of the program students should be able to learn to listen, speak, write and cooperate with co-workers and with the community. They should also seek, find and keep a job and meet the challenge of entering the business world.

There are three production groups consisting of four students per group. Each group will be producing their own half-hour documentary.

The first group concerns the Youth. The members are Travis McDaniel, Reggie Danforth, Angel Skenandore, and Vickie Hill.

The group went around and asked some questions to many adults and youths on what they thought were the main problems for youth on the reservation, what improvements could be made, and what they see for the future of the youth.

The third group concerns **Drug and Alcohol Abuse**. The members are Phil Doran, Carl Barnes, Rodney Reed, and Phillip Jordan.

Kim Hoerning is the telecommunication trainer for the summer project. Ed Delgado is the Education & Job Training Counselor for the youth.

At the end of August the tapes will be completed. There will be a showing of the three documentaries, announced at a later date.

LETTER TO THE EDITOR

That I am a member of this community, that I live here, choose to raise my children here, speaks to what I am first. It speaks to the investment and commitment that I have chosen to make. It is my dream to be a part of the history being made that will help the perpetuation of future generations.

That I am an employee of the Oneida Tribe which has been designed as a method to make goals and dreams a reality is what I am second. We are growing. We have become a large corporation. That we can speak of being a success in business is good, but that is not what makes us unique as a community.

We have given consideration to each other first, all of this time, as human beings and as families. My time invested with the Tribe has not been for personal gain or just employment, but as an investment in the future. A future I hope my children will be proud to be a part of.

Consideration has always been given to the women of our community. Let us not become so "big" that we forget the importance of the women. That social impacts on our people have created many single parent families, our traditions can speak to living with those conditions, keeping the best interest and welfare of our people in mind.

For those in a position that must "discipline" another member of the community, it is a difficult task. Because it is so difficult, I wonder if this is a new way in our community to treat each other? Is it a good way? Is it our way? Is there a better way? Is it a way we can learn and implement?

That employees are abusing sick time, do those people understand their role in the development of the Tribe? Has it been explained to them in a good way, how we are all part of this together, how their commitment to make this work is as important as the next person's?

For those who see working for the Tribe as "just a job" is there a greater damage being done? Have we all as members of this community spoken to the need for all of us to work together. Pity on those who do not have the vision to see past this work as more than "just a job".

Has the dictates of big corporation clouded our vision? Have we come to view our developments as employees vs administration? What of our beliefs that we are all equal, that we are all equally important? That everyone's ideas and opinions are valid and important? Let's not get too "big" that we forget we are a people first and that is truly our foundation for success.

Let's spend the time to reinforce our importance to each other, where we have been and where we need yet to go. That we have a long road ahead of us and that it is important that we travel that road with a clear vision, and that we maintain the tradition that has kept us strong all of this time.

Let's take the big business concepts and adjust them to meet **our** needs. For those who can clearly see the direction we must move in, for those who understand the vision, trust and faith in their commitment to that vision will in the long run get more than a straight 40 hour a week commitment.

For those who have swayed from that vision, who have become "I" centered, we need to pull those people back and remind them, at first gently but firmly, as it has always been done, with concern and respect, that we have a long way to go. There is still much work to be done. That we cannot sit back yet, we still have history to make and groundwork to lay for our next generations.

Give managers the training they need to work with sick time abusers. Allow those with a large number of sick time accumulated to be given credit due them. This much time accumulated speaks to a commitment on their part--they should not be penalized.

Speak to the issue of single mothers. Has consideration been given to the women employees of our Tribe? Is the personal holiday policy a big corporation technique? Do we spend enough time with our employees speaking to the importance of everyone's position? To rekindle the loyalty? Does everyone feel a part of the work being done? Do we make it clear and address it often enough? Have we used a team spirit approach? If not, why? That's really what we are, isn't it? Not just employees but the entire community.


