IN THE NEWS

BLACK HILLS CONTOVERSY

PRESS RELEASE

Members of the Oglala Sioux Tribe who have been encamped in the Wind Cave National Park in the Black Hills of South Dakota, have moved to a pic-nic area on the shores of Sheridan Lake in the Black Hills National Forest. The Sioux are protesting the wrongful century old taking of the Black Hills and expressing their claim for the return of the land. According to a report August 31 in the Aberdeen American News, Forest Service spokeswoman Mary Sue Waxler said the Indians were told that they were camped in an area where camping was forbidden by federal regulations and they would have to leave or face criminal charges. Members of another group, the Dakota American Movement, have been occupying forest service land at Victoria Lake since last April. Forest Supervisor James Mather said he gave the Dakota group a deadline of September 8th to move off the forest land.

According to the Oglala Sioux Chairman, Stanly Looking Elk, those members who had occupied Sheridan Lake, as of September 8th, have decided to meet with a B.I.A. official, concerning the controversy.

Deputy Assistant Secretary for Indian Affairs, Roy Sampsel, will meet with the Tribal Chairman, Sioux members and all other interested parties on September 11th at 10:00 a.m., in the town of Oglala, South Dakota to negotiate a settlement, regarding the Black Hills area.

The Dakota American Movement still occupies land at Victoria Lake, as of this publication.

BIA AREA DIRECTORS ANNOUNCED

Interior Assistant Secretary Ken Smith announced today that Maurice W. Babby, an Oglala Sioux, has been named director of the Bureau of Indian Affairs Sacramento area.

Babby succeeds William E. Finale, Sacramento area director since 1968, who has accepted an assignment as director of the Phoenix area for a period not to exceed six months.

Babby, director of the Bureau's office of administration in Washington, D.C., the past year, worked in the Sacramento office from 1958-1965. He was tribal operations officer and program officer in the area. He was superintendent of the Fort Belknap agency in Montana 1967-1970, and assistant area director at Billings, Montana 1970-1979.

PUBLIC FISHING ON THE BIGHORN

Fifty-two miles of the Bighorn River flowing through the Crow Indian Reservation was opened August 20 for fishing by the public. Many of the tribal members are bitter over the opening which came against their will, following a Supreme Court decision which determined that the State of Montana owned the river bed and banks. The Montana Fish and Game Commissioner decided last month to open the river to the public for fishing and hunting. The state had agreed to help enforce federal provisions against trespassing on tribal and trust lands and a tribal law against alcohol on the reservation.

These long nights have been strung together by our lives for 400 years and will grow in length, until when?

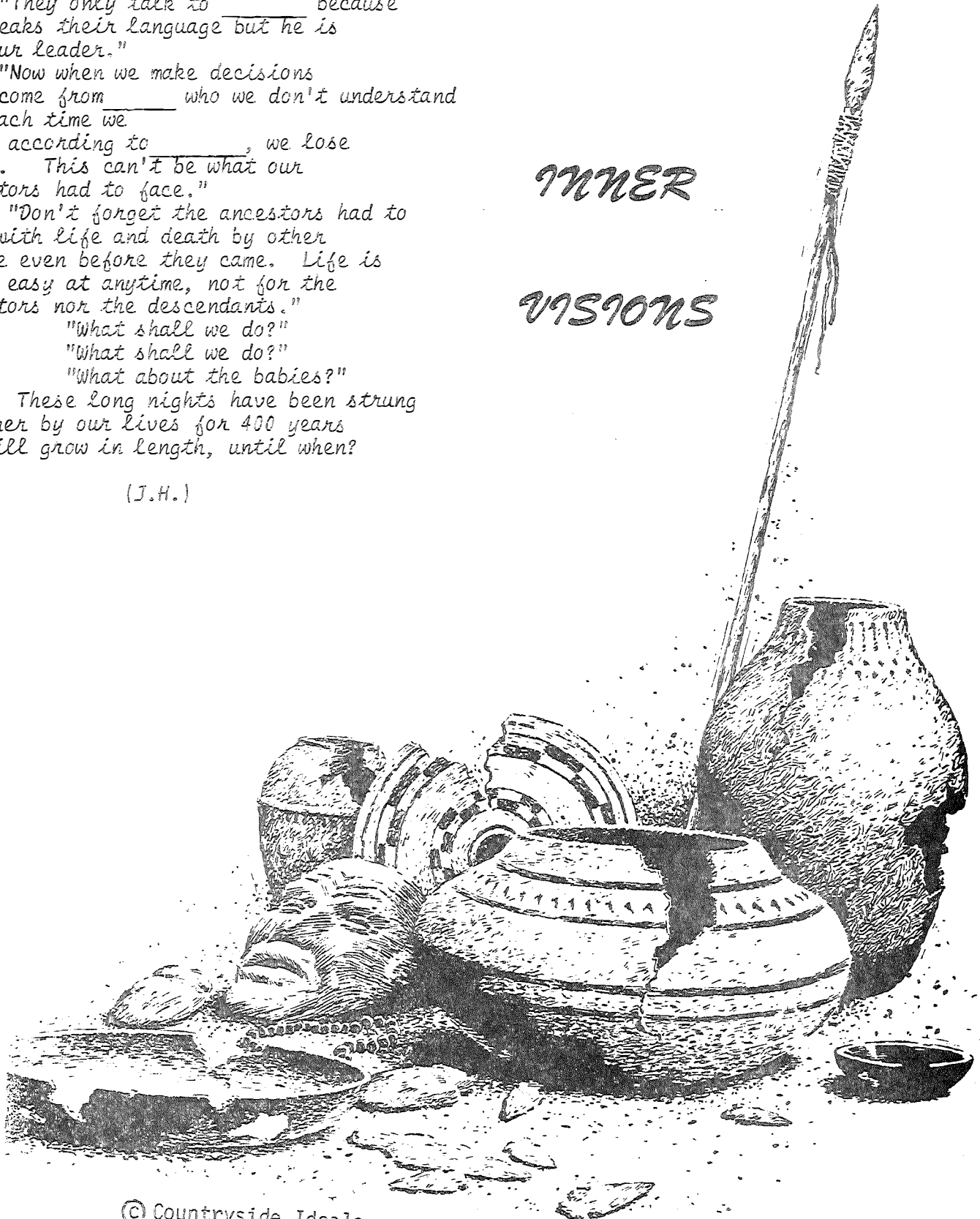



ABOUT INDIAN JURISDICTION

Worcester v. Georgia

In Cherokee v. Georgia Chief Justice Marshall denominated Indians as "domestic dependent nations" with a relationship to the United States resembling that of a ward to his gaurdian. This judicial sleight of hand did not suffice, however, in the next step of Cherokee conflict.

Samuel Worcester and several other missionaries who had objected vehemently to the treatment of the Cherokee decided to take the laws of Georgia to test still further. They entered upon and established residence in Cherokee country without the license required by the state of Georgia. They were immediately arrested, convicted and sentenced to four years of hard labor in a Georgia prison. However, they were all offered pardons and all but Worcester and Elizur Butler accepted. The two who refused pardons were anxious to bring a test case against the state. They petitioned the Supreme Court of the United States and the Court accepted.

Again Georgia refused to appear. The proceedings in the case were cloaked in a sense of foreboding due to the real possibility that both the state of Georgia and President Jackson would refuse to obey the orders of the Court. John Marshall, now in his mid seventies and in failing health took only two weeks to deliver an opinion. In context he makes reference to Emmerich de Vattel, one of the writers of international law as he states,

"---and the settled doctrine of law of nations is, that a weaker power does not surrender its independence -its right to self government, by associating with a stronger, and taking its protection."

Marshall then continues to reverse his opinion in Cherokee:

"The Cherokee nation, then, is a distinct community, occupying its own territory, with boundaries accurately described, in which the laws of Georgia have no force and which the citizens of Georgia have no right to enter, but with the assent of the Cherokees themselves, or in conformity with treaties, and with the acts of Congress. The whole intercourse between the United States and the nation, is, by our constitution and laws, vested in the government of the United States.

"The act of the state of Georgia, under which the plaintiff in error was prosecuted, is consequently void, and the judgement a nullity."

Judge Marshall's opinion in this case proved a political embarrassment to Jackson. He personally ordered the Governor of Georgia to pardon Worcester and Burler. Governor Lumpkin's pardon of the missionaries in 1833 ended the need for further test of the Court's power.

President Jackson's final words in the matter were, "John Marshall made his decision; now let him enforce it."

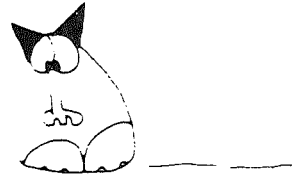

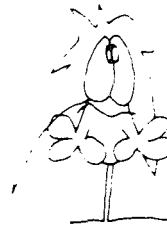

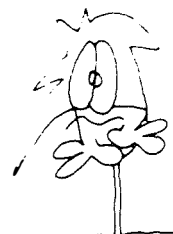

THIS SERVICE WILL HAVE THE PHYSICIAN ON CALL CONTACT YOU FOR YOUR HEALTH CARE NEEDS. THE PHYSICIANS HAVE MEDICAL PRIVILEGES AT ST. MARY'S HOSPITAL, AND IT IS NOT PRACTICE FOR THEM TO SERVE AT ALL THE THREE HOSPITALS.

Recipes

LOW SODIUM PICKLES

When canning vegetables, it is not necessary to add salt as a preservative.

General suggestions:

1. Use only fresh, firm cucumbers. Discard cukes that float when put into water; "floaters" make hollow pickles. Wash cukes thoroughly.
 2. Use high-grade vinegar of 5% acid strength. Check bottle label for information.
 3. Avoid using iron, copper, brass or zinc containers. Iron causes pickles to darken.
 4. Fresh or dried dill may be used. Be sure to include "heads" of fully developed seeds--that's where the strongest flavor is. Dill seed that has been kept in a tightly closed container can be substituted for fresh dill called for in recipes. Use 1 to 2 tablespoons of dill seed for each quart jar.
 5. If fresh grape leaves are available, add one or two to each quart. These leaves contain a substance which helps prevent pickles from softening.
 6. It is advisable to process pickles 20 minutes in boiling water. Processing destroys yeasts which cause fermentation and also drives some of the air from the jar. The less air left in the jar, the stronger the seal. When properly done, processing will not change the flavor of the pickles or break the jar. Have water in canner at the boiling point. Slowly lower jar straight down so the entire bottom of the jar touches water at the same instant. Be sure water comes an inch or two above jars. Start counting processing time as soon as the jars have been put in the canner. Let boil gently. Remove jars from the canner at the end of processing time and stand them out of drafts several inches apart to cool.
 7. It takes 3 to 4 weeks for pickles to develop even color and food flavor.
- Salt free pickles need much more dill and other seasonings than other pickles to give a good flavor.

20 - 25 dill sized cucumbers

For each quart add:

1/8 tsp. alum

1 or 2 cloves garlic

1 or 2 grape leaves

3 heads or more of fresh dill or 1 to 2 TBSP dill seed.

Optional:

1 hot pepper or 6 pepper corns

1 TBSP whole pickling spice

2 tsp whole mustard seed

fresh horseradish

Syrup:

6 Cups vinegar (1½ quarts)

9 Cups water (2½ quarts)

1/4 Cup sugar (optional)

Wash cucumbers thoroughly, scrub with brush and drain. Let stand overnight in cold water. Pack in sterilized jars. To each jar add: alum, garlic, dill and grape leaves. Cover with boiling vinegar and water to within ½ inch of top of jars and store upright.

PICKLED GREEN PEPPERS

3 Pounds Green Peppers (7-9 large)

Boiling Water

2½ Cups Vinegar

2½ Cups Water

1½ Cups Sugar

8 Cloves Garlic

4 tsp. salad oil

Wash peppers. Remove seed pods and white "seams". Cut lengthwise into 3/4 inch strips. Place pepper strips in bowl; Cover with boiling water. Let stand 5 minutes. Drain. Combine Vinegar, water and sugar in saucepan; simmer 5 minutes. Meanwhile, pack peppers into clean, hot jars-to each jar add 2 cloves garlic and 1 tsp. salad oil. Pour hot liquid over peppers to within ½ inch of top, making sure vinegar solution covers peppers. Cap each jar at once. Process 5 minutes in boiling water bath. Makes 4 pints.
