## Oneida Tribal School Release Statement

The Oneida Tribal School today announced its policy for children unable to pay the full price of meals served under the National School Lunch Program and/School Breakfast Program.\* Each school office and the central office has a copy of the policy, which may be reviewed by any interested party.

The following household size and income criteria will be used for determining eligibility. Children from families whose income is at or below the levels shown are eligible for free and reduced price meals.

Application forms are being sent to all homes with a notice to parents or guardians. To apply for free or reduced price meals, households must fill out the application and return it to the school. Additional copies are available at the principal's office in each school. The information provided on the application will be used for the purpose of determining eligibility and may be verified at any time during the school year by school or other program officials. Applications may be submitted at any time during the year.

For the school officials to determine eligibility, the household must provide the following information listed on the application: Names of all household members; social security numbers of all adult household members or a notation that the household member does not possess one; total household income must be listed by the amount received by each household member receiving income and the type of income it is (such as wages, child support, etc.) or a food stamp case number if the household is on food stamps; and the signature of an adult household member certifying that the information provided is correct. Households are required to report increases in household income of over \$50 per month or \$600 per year and decreases in household size.

Under the provisions of the free and reduced price meal policy M. Sue Christensen will review applications and determine eligibility. If a parent or guardian is dissatisfied with the ruling of the official, he/she may wish to discuss the decision with the determining official on an informal basis. If the parent wishes to make a formal appeal he/she may make a request either orally or in writing to: William Gollnick, Administrator — 3000 Seminary Road — Oneida, WI 54155 — 869-2795 for a hearing to appeal the decision. The policy contains an outline of the hearing procedure.

If a household member becomes unemployed or if the household size changes, the family should contact the school. Such changes may make the household eligible for reduced price meals, or for additional benefits such as free meals if the family income falls at or below the levels shown above.

In certain cases foster children are also eligible for these benefits. If a household has foster children living with them and wishes to apply for such meals for them, the household should complete an application for a family of one or contact the school for more information.

The information provided by the household on the application is confidential and will be used only for purposes of determining eligibility and verifying data.

In the operation of the child feeding programs, no child will be discriminated against because of race, color, sex, national origin, age, or handicap. If any member of a household believes they have been discriminated against, they should write immediately to the Secretary of Agriculture, Washington, D.C. 20250.

Any questions regarding the application should be directed to the determining official.

I.M.S. is a federal agency that offers general operating support to the nation's museums. The agency received 1,264 applications for the 1985 general operating support competition and made 449 awards totaling \$16,723,000.

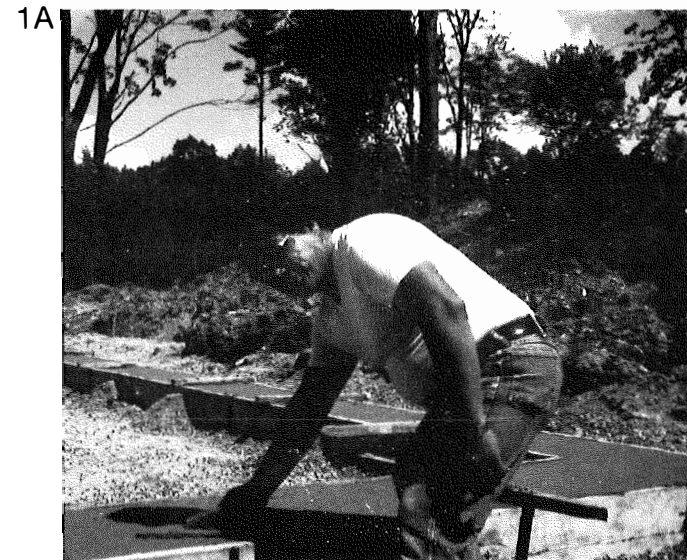
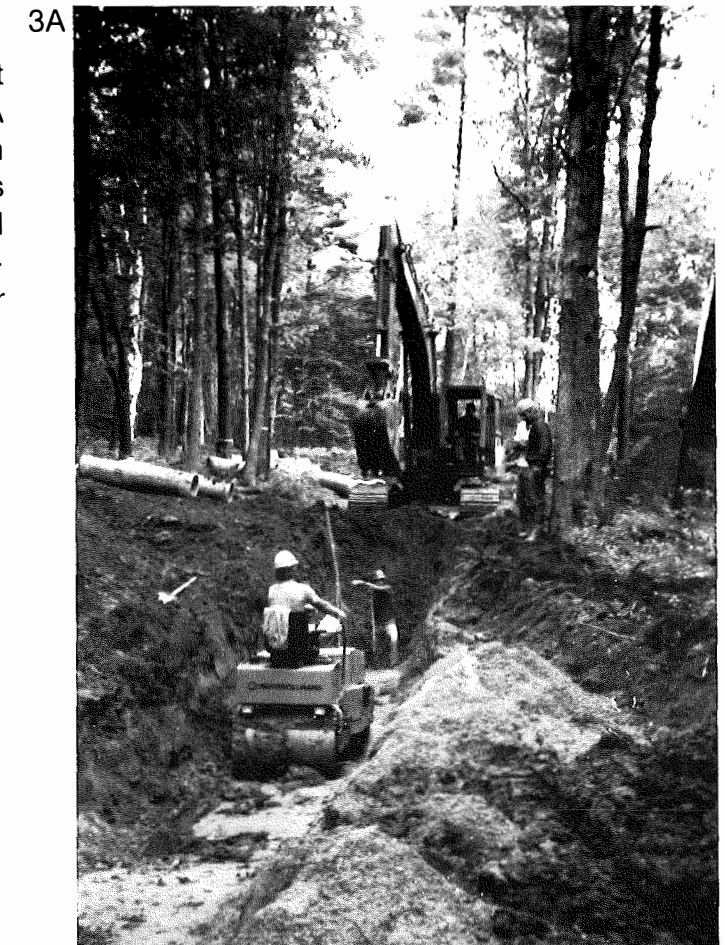
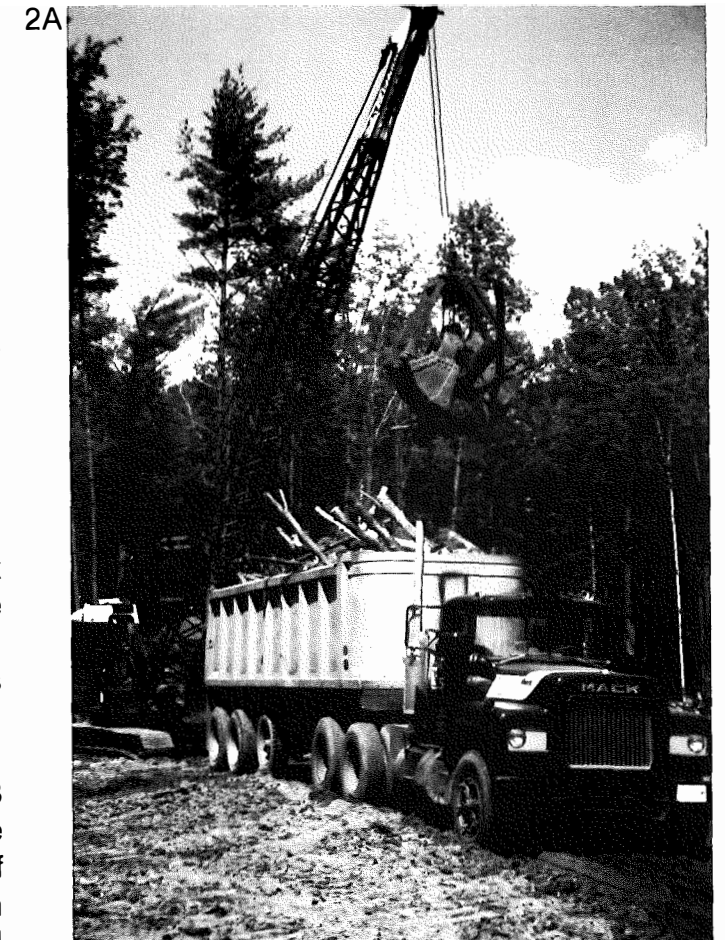
## Oneida Roadway Inn Construction Continues

Progress continues to be made on the construction of the Oneida Roadway Inn. Footings began to be poured during the week of July 10 and on July 17 work began on the foundation walls.

The construction management firm of Geupel DeMars has completed a detailed work schedule to have the building “closed in” by the first week of December. This allows measurement of progress on a week by week basis between now and then.

Nearly three quarters of the expected 23 contractors for different trade areas on the project have received contracts or letter of intent. Of the total \$6.5 million in construction costs it appears that over \$2.25 million (35%) will be going to Oneida owned contractors.

# Angie Gonzalez Earns National Honors

(ONEIDA, WI) — An Oneida girl is being honored as one of the ten outstanding Indian students in the nation. Angela Gonzalez, the 13-year-old daughter of Roland and Mary Lemieux, 1170 Ranch Road, Oneida, will be honored in ceremonies this Friday (July 12th) in Washington, D.C.

Angela is being honored as a result of achievement tests and local school assessments administered in connection with the Evaluation of Indian Controlled Schools. She will receive a certificate of distinguished participation in the competition which was sponsored under Congressional order by the U.S. Department of Education.

The awards ceremony will be held at noon (July 12, 1985) in the Capitol Holiday Inn (550 C. St., S.W.)

A total of 250 eighth grade students from 63 Indian controlled schools took part in the competition. A similar competition was held for 150 twelfth grade students from 19 Indian controlled schools in the country.

Students had to fit stringent criteria to be nominated by their school administrators for the competition. William Gollnick, administrator of the Oneida Tribal School says that in addition to being an exemplary student, Angela was the valedictorian of this year's 8th grade graduating class.

She and eight other students were evaluated academically as well as on their knowledge of the Oneida Language, Oneida Culture, Oneida Law and in the area of self-concept/attitude.

The results of the testing for the nine students were sent to an independent firm selection by the U.S. Education Department for judging.

Angela is an only child. Her mother, Mary, says Angela learned to love books at an early age and is now an avid reader.

Earlier, Angela was one of 285 students in Wisconsin selected to attend the Wisconsin Science World '85 Camp. Unfortunately, she was unable to attend.

Angie, as she is known by her family and friends, taught herself to swim. She loves to dance and is a big fan (number #1, she says) of the Rock Star Prince.

She will attend Seymour High School in the fall, and, as a result of this latest honor, is talking of going on to college, "perhaps an eastern school."

"Before," her mother says, "she wanted to be a rock star."

# Summer Session Receives \$5,000 Grant

The Diocesan Services Appeal of the Catholic Diocese of Green Bay has given a \$5,000 grant to the Oneida Tribe of Indians for its Super Summer Session. Super Summer Session is summer-school-type activity which provides an educational experience in language arts, mathematics, and arts and crafts. About 315 students aged 4 through the 12th grade are taking part in this year's session.

A staff of 65 teachers is working with students at the pre-school, primary, intermediate and junior-senior high school levels. Classes began June 24th and last through July 19th.

This is the 16th summer for the program which includes students from both the Indian and non-Indian communities near Oneida.

Sr. Diane Poplawski, O.P., Coordinator of Super Summer Session says the \$5,000 DSA grant will be used to offset operational costs of the program.

# Another Successful Program Completed

## Oneida Indian Summer Session 1985 — Sixteenth Summer

The Oneida Indian Summer Session of 1985 completed another successful program on July 19th. This year, the program, had an enrollment of 313 students and of those students 80 were honored with Perfect Attendance awards.

On Wednesday evening, July 17th, at Norbert Hill Center an OPEN HOUSE was held for the community, family and friends. The program began with parents, friends and students visiting the various classroom areas at 6:30 P.M. Student beading, leathercraft, ceramics, basket weaving, artwork, model building and Native Dress Design articles were displayed. Programs were presented in learning areas and incorporated songs, stories, Oneida Language, and other skills learned and shared over the summer. A program in the auditorium at 8:00 P.M. included a style show by the Junior and Senior High students of the Native Dress Design class. The program concluded with a slide show reflecting the learning experiences and memories of the 1985 summer session.

Approximately 400 people shared in the evening which closed with refreshments and a social in the cafeteria.

# The Associate Degree/Weekend College University of Wisconsin-Stevens Point, WI

The Associate Degree/Weekend College at the University of Wisconsin-Stevens Point has been in existence since the Spring of 1982. At present, 50 students are working to complete an Associate Degree in the liberal arts.

This is an entry level degree opportunity, meeting the requirements for the first half of the Bachelor's Degree requirements.

Over a length of time, American Indian students can work towards a degree while maintaining close ties to family and community.

Through a unique "weekend format" schedule, the students can also continue to work full-time in their respective community areas. Our students come from all eleven reservation areas throughout the state of Wisconsin.

Classes in Indian law, psychology, history and literature are included in the curriculum. Emphasis on Native American perspectives adds relevance and interest to much of the course work.

Classes are held at the University of Wisconsin-Stevens Point on Fridays and Saturdays on a two weekends on, one weekend off format for ten weekends per semester.

Class scheduling and content is designed to allow students with family and job responsibilities the opportunity of earning an entry level degree. Independent study courses and credit for prior learning are available.

The Associate Degree/Weekend College can provide an individual with better job opportunities, improved self-esteem, a new outlook on life and new friendships. We provide specially designed courses, financial aid counseling, career counseling, academic advising, individual tutoring, a Native American studies emphasis and a weekend format.

We have some openings in the program and invite you to explore the opportunities of the Associate Degree/Weekend College for Adult Tribal Members. # Let God Fight Your Battles!

(continued from August issue)

Now I want to bring you a case history — a remarkable experience that will show you the way out of all your difficulties and troubles.

If you will let GOD have His way in your life, then you will have begun to learn how to let Him fight your battles, solve your problems and deliver you from so many troubles you are suffering.

Now, notice the experience written for our learning and help today:

“It was after this that the Moabites and Ammonites, with some of the Meunim, made war on Jehoshaphat. Word came to Jehoshaphat that a huge host was moving against him from Edom, over the Dead Sea, and that they were already at Hazazon-tamar (or Engedi). Jehoshaphat was afraid” (2 Chronicles 20:1-3, Moffatt).

Is fear your usual reaction, too? But observe what the King of Judah did.

“He resolved to have recourse to the Eternal, and proclaimed a fast all over Judah. So Judah assembled to seek help from the Eternal; people came from every town in Judah to worship the Eternal” (verses 3-4).

Jehoshaphat did exactly what God wants you to do today when faced with any temptation or trouble — HE TOOK IT TO GOD IN PRAYER AND FASTING!

And as he continued to ask God for help, he said (verses 6-10): “O Eternal, the God of our fathers, art not thou God in heaven, and ruler of all realms on earth? Such power and might is thine that no one can resist thee. O our God, didst not thou evict the natives of this land before thy people Israel, giving the land to the offspring of Abraham thy friend, for all time? And they settled in it, they have built a sanctuary in it to thine honor, thinking that if evil befell them, the sword in judgment, or pestilence, or famine, they would stand in front of this temple and before thee (for in this temple is thy presence) and cry to thee in their distress, till thou didst hear and save them.

“Now here are the Ammonites and Moabites and folk from Mount Seir, whom thou didst not allow Israel to invade, when Israel came out of the land of Egypt — no, Israel turned away from them and did not destroy them!”

There was no reason for these neighbors to be enemies. Sometimes, our own neighbors become your enemies, too, don't they?

But notice what the King said to God: “Look how they reward us, coming to eject us from thy very own country which thou hast given us to be ours. O our God, wilt thou not deal with them? We are helpless against this mighty host that is attacking us; we know not what to do, but we look to thee” (verses 11-12).

## GOD ANSWERS PRAYER

Now I want you to notice! Jehoshaphat cried out for God to come to their aid. Here is God's answer (verses 14-17):

# ONEIDA COMMUNITY CANNERY

Canning is a prideful and satisfying skill, as well as an economical way of preserving food while it is plentiful and inexpensive. With the rising cost of food, the people of the Oneida Community will have the opportunity to save on their food dollar this summer. The Community Cannery is located in the Norbert Hill Center, Room 1176, Hours 8:00 to 4:30, Monday through Friday. The Cannery has all the equipment you need to can and process your foods with. Time is saved in processing with the pressure cookers and atmospheric cookers (hot water bath). One appointment for canning may take 1½ to 2 hours. Some even less. There is help available to assist you with your canning. Call 869-2737 for more information. For those of you who are planning to do food preservation, start buying jars and lids now. This will help your budget when garden produce is ready to harvest and can.



“Jehaziel... was inspired by the spirit of the Eternal in the midst of the gathering to cry, ‘Listen, all ye men of Judah, ye citizens of Jerusalem, and you, O King Jehoshaphat; the Enternal’s message to you is this: “Fear not, falter not before this vast army; it is for God, not for you, to fight them. March down against them tomorrow; they are coming up by the ascent of Haziz, and you will come upon them at the end of the ravine in front of the desert Jeruel. You will not need to do any fighting; take up your position, stand still, and watch the victory of the Eternal, who is on your side, O Judah and Jerusalem. Fear not, falter not. Move out against them tomorrow, for the Eternal is on your side.””

And notice that Jehoshaphat obeyed after God instructed him. Verses 20-23 declare: “Next morning they rose and moved into the open country round Tekoa. As they advanced, Jehoshaphat stood and said, ‘Listen men of Judah and citizens of Jerusalem! Take hold of the Eternal your God and you will keep hold of life; hold by his prophets, and you will prosper!’

“After this counsel to the nation, he appointed the Eternal’s singers to praise Him in sacred vestments, marching in front of the army and chanting, ‘Give thanks to the Eternal, for his kindness never fails.’

“As they began to sing and praise him, the Eternal set men in ambush, against the Ammonites, the Moabites, and the folk from Mount Seir, who had attacked Judah, and they were routed. The Ammonites and the Moabites turned on the natives of Mount Seir, determined to wipe them out.”

They turned against one another! That is how God answered Jehoshaphat “And then, after destroying the natives of Seir, they all helped kill one another. So when the men of Judah reached their post of attack looking over the open country, they saw the host were so many corpses stretched upon the ground; not a man had escaped” (verses 23-24).

Jehoshaphat did not merely leave this trouble with God and then do nothing about it himself. First, he prayed and asked for wisdom, guidance and HELP. Then he DID WHAT GOD SAID. He had to do his part — but the battle was God’s and Jehoshaphat did not try to fight God’s battle. He merely did his own part. But he believed God, and relied on God.

The point I want you to remember is that your battles are not really yours, but God’s. If you look to Him, He makes them His battles, and He fights them for you. How futile for you to try to fight God’s battles for Him.

God says, “Many are the afflictions of the righteous, but the Lord delivers him out of them all” (Psalm 34:19).

In the New Testament we read, “By grace are ye saved through faith” (Ephesians 2:8, authorized version). Yes, but the faith that saves us is a living faith that is practical — it works — it really relies on God! So put it to practice!

God does not promise us an easy time during this life in this world. But He does promise to fight our battles for us — to deliver us from every trouble and affliction.

Will you let Him do it, and learn how happy your life may become? God help you to understand!

## Home Canning Basics

The processing time is a very important part of home canning. If you have ever had lids unseal or food spoil after it has been home canned, the cause may have been underprocessing.

Begin counting the processing time after the jars are placed in the water bath canner and the water has come back to a boil. When canning in a pressure canner, begin counting the processing time when the pressure reaches a steady 10 pounds.

Processing times given in home canning are different for each type of food and amount of food. Recommended processing times are determined by several factors — how acid the food, how thick, whether food is being raw packed or hot packed, and jar size.

Another recommendation is to use standard canning jars; empty mayonnaise jars or peanut jars are not made to withstand home canning. Many times metal utensils are used to remove food from the commercial jars; if the jar is scratched, it may break at that weak point while being heated.

The commercial jars not only break more easily but may actually hold more food than a standard canning jar. If processing is done according to standard recipe processing times, the food may not be heated through to the center of the jar and be under processed. Under processed foods will spoil and be unsafe to eat. Processing times need to be exact, and it's hard to do with odd-sized jars.

Sealing is another problem even though two-piece home canning lids appear to fit correctly on commercial jars; the lids may unseal later. The jar rim on a commercial jar may not be as even or as wide as a canning jar. There is space for air to enter.

Don't experiment with your family's health.

RESOLUTION NO. 12-5-83-A

WHEREAS, the authority of the Oneida Tribe of Indians of Wisconsin is recognized by the treaties with the United States; and,

WHEREAS, the Oneida General Tribal Council has delegated to the Oneida Business Committee authority to exercise the enumerated powers of the Oneida Constitution, Article IV as amended; and,

WHEREAS, the Oneida Business Committee was given the responsibility for the health, safety, and welfare of Oneida Tribal members; and,

WHEREAS, the Oneida Community Health Center is charged with addressing the physical and mental health needs of Oneida Tribal members; and,

WHEREAS, the Indian Health Service and the Oneida Tribe has identified alcohol and other drug abuse as the No. 1 health problem of Indian people; and,

WHEREAS, the continued and unrestricted practice of serving minors directly contributes to numerous traffic violations, automobile fatalities, disturbances of peace, public and domestic violence, sexual abuse, suicide and attempted suicides, drug overdoses, family disturbances and disorganization, and many other undesirable social consequences; and,

WHEREAS, the Chemical Dependency Program of the Oneida Community Health Center has established that one of the contributing factors to alcohol abuse is the serving of alcoholic beverages to minors of the Oneida Tribe; and,

THEREFORE BE IT RESOLVED: That the Oneida Tribe will initiate the first steps to coordinate and cooperate with local law enforcement agencies in both Outagamie and Brown Counties in terminating any such violations on the Oneida Reservation in accordance with State law and Tribal policy; and,

BE IT FURTHER RESOLVED: That the Business Committee, hereby directs the Chemical Dependency Program to develop a Tribal policy addressing alcohol and drug abuse; and,

BE IT FURTHER RESOLVED: That active community involvement will be solicited for all efforts related to this endeavor to eliminate alcohol and drug abuse in the Oneida Community.

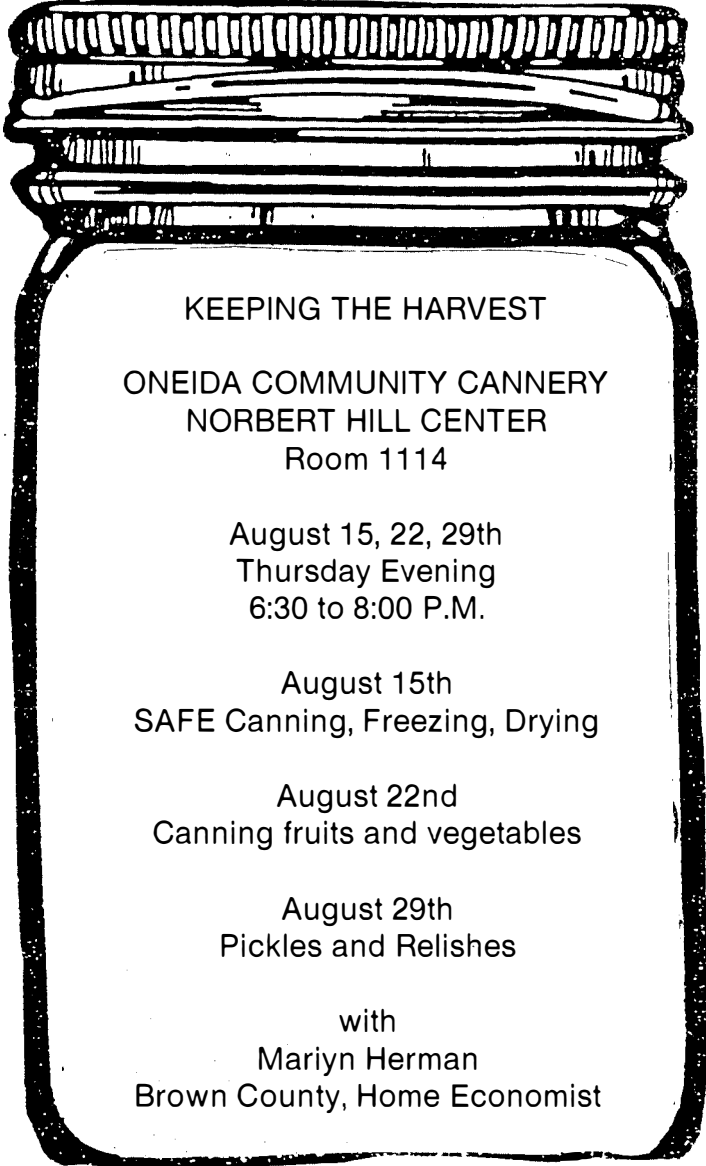

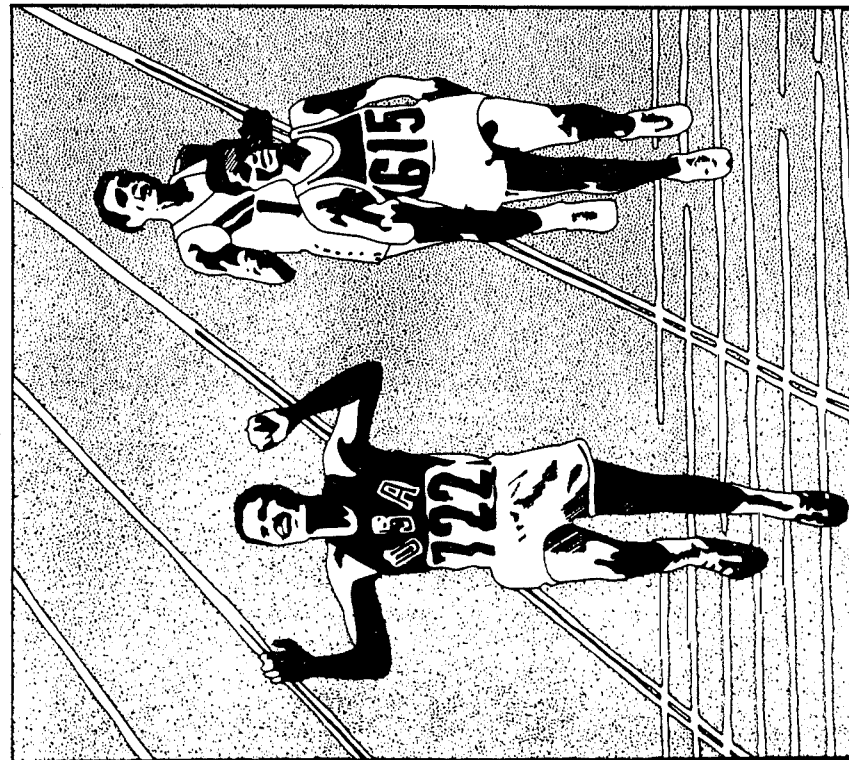
