### **US** officials reject Catskill casino plans

WASHINGTON (AP) ~ The federal government has rejected plans for two Indian casinos in the Catskills, saying the gaming sites aimed at drawing high rollers from New York City might leave their faraway tribes worse off.

The St. Regis Mohawk Tribe had sought to build a \$600 million casino in Monticello in Sullivan County, about 90 miles from New York City. The Stockbridge Munsee of Wisconsin had also sought to build a casino in Sullivan County. Both were rejected in

### **UAC** closes doors due to lack of funds

The United Amerindian Center (UAC) in downtown Green Bay has shut its doors on Monday January 14 due to a lack of funding. Stephen Crowe, the center's director, is confident the closure is temporary.

"Most grants require a federal contract; we were declined right away for those.

We have a lot of requests to private firms. It is not an overnight process, I wish it was. I am very confident and it is just a matter of time before we get funding. A lot of the grants will be reviewed in February and we are calling and trying to push these decisions soon. As a last resort I am looking at a home equity loan," said Crowe.

Recently the UAC requested additional funding from the Oneida Tribe but was ultimately declined. The Oneida Tribe donated \$100,000 in June of last year.

The UAC had about 1000 clients utilize the center in December. The UAC provides alcohol and drug treatment, transportation and medical services to Native Americans

not living on Indian reservations. According to Crowe, medication will still be delivered for elderly or disabled.

Crowe has advised clients of the UAC to utilize the Oneida Health Center, Oneida Transit, Green Bay Transit and the Native American Services Center to secure transportation and other ser-

Crowe has been discussing the center's closure with his staff since December. "I did talk to the employees and staff and advised them we may need to close at the Christmas dinner. I told them about the most recent tax bill

### New tobacco tax could mean rise in sales

January 1, 2008 was the start of the highest cigarette tax hike in Wisconsin history. The tax jumped from \$.77 per pack of 20 cigarettes to \$1.77 per pack of 20 cigarettes. The revenue from one dollar increase will be used, in part, to help provide smoking cessation products and counseling to Wisconsin residents wanting to kick the habit.

The tax hike is also designed to deter non-smokers from picking up the habit. Primarily aimed at teens, the barrier to entry, \$4 - \$5 per pack, may be too high for school age kids to hurdle and thus prevent them from ever starting up cigarette smoking. For Oneida vendors locally though, the effect may be just the opposite.

The Oneida retail outlets are expecting to see a rise in their cigarette sales across the board.

Wayne Skenandore, Oneida Retail Assistant Manager, said, "Well we've already seen, before the tax went up, our sales jumped dramatically December. Normally we sell 50,000 [cartons] in December it jumped up to almost 60,000 [cartons], almost 20 percent."

They are expecting that trend to increase due to the lower price that Oneida can sell their

cigarettes.

increase by 10 to 20 percent. Our sales will increase and the reason is...because of the way we price, we now price \$10 less [per carton] than the lowest price in our market area. Anybody that does smoke will now drive and buy from us. So even though the market is shrinking, our sales are going to dramatically," increase Skenandore explained.

Although Oneida Retail expects to sell more cigarettes, the data to confirm the prediction won't be available for a few months.

"January and February typically are extremely low months as far as cigarette sales because people make the end of the year resolutions. We won't really be able to see any conclusive results from this tax change for at least six months," Skenandore

As for the people that already smoke cigarettes, will the new tax help them kick the habit?

"No absolutely not," said Jody Cornelius, owner of J&A Quick Lube and a smoker.

He doesn't believe the tax could ever be high enough to prevent from smoking.

"I don't believe there is that point. When it comes to the satisfaction I get from cigarette smoking, I don't think [the tax "We expect our sales to is] even a factor."

separate letters to tribal leaders by Department of Interior Associate Deputy Secretary James Cason.

The letters were sent to tribal leaders late Friday.

Both applications center around the hotly-disputed question of whether tribes should be allowed to establish casinos far away from their reservations. The St. Regis Mohawk tribe is located about 350 miles north of its proposed site. The Stockbridge Munsee are more than 1,000 miles away.

"The remote location of the proposed gaming facility may encourage reservation residents to leave the reservation for an extended period to take advantage of the job opportunities created," Cason wrote in identical language to the two tribes. "The potential departure of a significant number of reservation residents and their families could have serious and far-reaching implications for the remaining tribal community and its continuity as a community."

The decision was quickly criticized by Rep. Maurice Hinchey, a lawmaker who has strongly supported the casino plans.

"It is clear that the next opportunity for these proposed casinos to move forward and be objectively evaluated will be under a new administration by a different Secretary of the Interior," said Hinchey, D-Hurley.

Hinchey and the St. Regis tribe have long maintained that Interior Secretary Dirk Kempthorne has not fairly considered the proposal, because when he was the governor of Idaho he firmly resisted off-reservation gam-

The St. Regis filed a lawsuit late last year accusing Kempthorne of stalling the approval process.

The Stockville Munsee had sought to approval to acquire in trust a 333-acre parcel in the town of Thompson. The St. Regis Mohawks had sought to acquire a 29-acre parcel.

Proponents of the St. Regis casino envision an entertainment complex with approximately 125 table games, 3,500 slot machines, 24 poker tables, and numerous restaurant and retail venues, that they claim would create more than 3,000 permanent jobs.


going for a degree in Exercise Physiology, Physical Education or a closely related field. This would give them the hands on experience in working closely with the Fitness Specialist in there day





### **SEOTS looks to make changes**

The South Eastern Oneida Tribal Services (SEOTS) has been holding community meetings in Milwaukee to determine the need for additional space for SEOTS.

According to Linda Torres, Area Manager for Social Services, a series of meetings called Visioning Sessions have been held gather community input on the project.

Currently, SEOTS is operating out of a 1500 square foot building which has limited it programming abilities and made daily operations less than comfortable.

"They can't run, for example, two programs at once. They don't have that space. The only space they have is that 1500 square feet. So if they had to do after school programming they would have to go with programming from three to four thirty and then they could do something else after that but the first group had to be gone before they could have another meeting," Torres explained. "The SEOTS board meets twice a month and if they wanted to go into Executive Session... [they would] have to go down into the basement and the basement wasn't part of the rental so we'd have to ask for permission to use the basement."

According to Torres, SEOTS is looking to acquire a new building that will have approximately 7000 square

"We hope to have them move, probably this spring, if all goes well."

SEOTS provides social services for the Oneida members living in the Milwaukee area. Including social programming, culture and language classes, and outreach education. They also provide transportation to the Oneida Health Center pharmacy monthly to fill 900 prescriptions for its 757 families which combined comprise over 2000 Oneidas in the Milwaukee area.

SEOTS is hoping to expand services as well as square footage with the acquisition of a new building.


"The current building just wasn't conducive to the type of programming they wanted to get into more of. A lot of their program was outreach and now they're hoping that with the bigger space that they're going to have, they can bring the programming there," Torres said.

She also noted that new services will mean more work.

"We are looking at adding on to programming and increasing the work that the staff can do down there. If we increase programming down there, are we going to need to increase staff."

Following the conclusion of the Visioning Sessions, a business plan will be developed to determine the future needs of SEOTS.



### Potawatomi casino officials look into off-track betting

MILWAUKEE (AP Potawatomi casino officials have been negotiating with out-of-state tracks to simulcast their races and take bets on them at the Menominee Valley facility, a spokesman for the Forest County Potawatomi tribe says.

"It's allowed in the (tribe's state gambling) compact, and the customers have been asking for it," Ken Walsh said, adding that off-track betting could begin this year when the casino completes its \$240 million expansion.

The Oneida casino near Green Bay and the Ho-Chunk casino near Baraboo already offer off-track betting.

Such a move could affect the financially struggling Dairyland Greyhound Park, where the \$53.7 million wagered last year included \$38.9 million on simulcast races run at more than 50 horse, harness and dog tracks. The 2006 total of \$57.9 million included \$40.6 million bet on simulcast races.

"We're not in the business of being in the casino industry," said Roy Berger, Dairyland executive vice president. "Where on earth do they come off taking what little sliver of the market we have left?"

The track lost \$2.8 million in 2006, the latest for which figures were available.

Berger said attempts by Dairyland, the state's only dog track, to offer slot machines to compete with Indian casinos have been rejected, while the state gave tribes the go-ahead to compete with Dairyland.

In 2003, when the state agreed to allow Potawatomi and other tribes to offer off-track betting Potawatomi officials assured then-state administration secretary Marc Marotta that they would not offer simulcasting as long as Dairyland stayed in business. Marotta said the tribe wanted the authority to offer simulcasting in the event the track closed.

But Walsh said the situation is different now.

For one thing, he said, the original compact gave the tribe exclusive rights to offer casino games within 50 miles but that provision was later eliminated by the federal government.

Walsh also noted that Dairyland has unsuccessfully challenged the legality of Indian casinos in court.

"A lot of things have happened since then, including Dairyland's efforts to end Indian gaming - continued efforts," Walsh said.

An application is pending at the U.S. Department of Interior for Dairyland to sell its facility to the Menominee

Berger said that, if the Potawatomi offered off-track betting, it would not force the dog track to close. The track would rather consider adding services such as an entertainment complex, he said.

For quite some time now, the Oneida Tribe has worked hard to establish a more positive relationship with Hobart's leadership for the benefit of both the Hobart community and the Oneida Tribe with the hope that the economic benefits of a prosperous gaming economy will benefit both communities. Unfortunately, it's becoming ever more apparent to me, that Hobart's leadership has other interests and maybe the Tribe would be better off recognizing that. #### Wage Compensation **Information for FY 2008**

In October, the General Tribal Council passed funding for a 3% wage increase for Tribal employees. GTC also provided funding to increase wages of those Tribal employees whose wages have not kept up with the market in their particular

On January 23rd, the Oneida Business Committee is scheduled to consider the Tribe's Wage Compensation Plan for 2008. The Plan, will be submitted by Tribal management and be based on the consultant's (Valliant) recommendations. Preliminary indications are that under the proposed plan, approximately 250 employees will receive no raises in 2008 and an undetermined number of employees will receive raises of only 1% and 2%. If that is part of the recommendation package, I will not vote to approve that portion of the Plan. Also, indications are that the proposed will contain no cost of living provision for annual wage adjustments to keep up with inflation, and again, if cost of living is not part of what is being proposed, on behalf of my Office as an elected Councilman for the Oneida Tribe, I will not support the Plan. However, my Office will support any portions of the plan that provide for cost of living adjustments, increasing employee wages for those whose wages have fallen below market, and any provision that is consistent with values that will promote

### Don't deny vote for Milwaukee Oneidas

Good Morning or Good Afternoon,

I do not have enough time to complete every thing I believe to be most important: We the people were beginning to be on a highway of liberties together beginning with most of O.B.C. members refuse to honor our constitution. #### ONEIDA ELECTION BOARD NOTICE

CHALLENGE TO YOUR GTC CONSTITUTIONAL **RIGHTS** 

The following motion was made at the GTC Semi-Annual Mtg of July 11, 2005 regarding the amended Oneida Election Law.

Motion by Amelia Cornelius to defer this item back to the LOC and the Election Board to work together to come forward with a document that is approved or agreed upon by both parties, seconded by Ed Delgado. Motion carried.

The Legislative Operating Committee has been working

diligently for the past three (3) years on the proposed amended Oneida Election Law. The Election Board would like the people to be aware and comment on two important proposed changes:

1) 2.5.4. A person may not run for more than one (1) elective office or seat per election. (page 76 in the 2008 GTC Annual meeting and report)

Election Board Position- Is it unlawful to restrict an individual's right to run for more than one elected position.

2) 2.9-1. Polling site in Milwaukee . . .

(page 81 in the 2008 GTC Annual meeting and report) In the Oneida Constitution Article I- Territory states "The jurisdiction of the Oneida Tribe of Wisconsin shall extend to the territory within the present confines of the Oneida Reservation and to such lands as may be hereafter added thereto within or without said boundary lines under any law of the United States, except as otherwise provided by law." The Oneida Tribe has neither land nor jurisdiction in the Milwaukee area.

The Election Board is proposing consideration of the following options to GTC in regards to the Oneida Election Law and language regarding an off-reservation polling site:

- 1) Disallow for the Milwaukee Polling site and place this on the 2008 General Election ballot in the form of a referendum question for consideration of GTC, asking if GTC approves a Milwaukee polling site. If the majority supports a Milwaukee Polling site, a resolution will be drafted for GTC's approval.
- 2) Discontinue the Milwaukee polling site, at this time.
- 3) Continue the Milwaukee Polling site and, as in Option 1, place a referendum question on the 2008 General Election ballot asking if GTC approves a Milwaukee polling site. If the majority supports a Milwaukee Polling site, a resolution will be drafted for GTC's approval.
- 4) Continue the Milwaukee Polling site as BC Resolution 03-12-02-0 currently reads.

of the Oneida Tribe. Willman is

an know throughout Indian country and a proponent of changing current Federal Indian Policy concerning the rights of nontribal American citizens to not be governed by Tribal Governments.

I recently had the opportunity of a question and answer session with Ms. Willman...

Were you contacted by Hobart about the position before or after you lectured there in late 2007? The initial concept of pos-

sible employment with the Village of Hobart was somewhat simultaneous with an invitation to speak to the Hobart community in September 2007. More specific discussion of future

employment evolved after meeting community members, Village elected officials and staff.

> What do you see as your primary roll/responsibility for the Village of Hobart?

My duties will include community and economic development tasks such as pursuing moderate income housing opportunities, commercial and light industrial opportunities for

the Village, as well as involvement and consultation with all matters occurring between the tribal government and local general purpose government.

How will your experience dealing with Native American **Governments** help you accomplish your goals in your new position?

Having lived within the exterior boundaries of the Yakama Indian Reservation for 15 years, I have had direct experience with their tribal government as the City of oppenish's Community Development Director, as a hired consultant for the tribe, as an elected official (Toppenish City Council) and as a private citizen. Many of

these experiences with tribal leaders were very, very positive. Only when the tribal government desired to tax, regulate and impose its authority over non-tribal citidid conversations become difficult and/or adversarial. I believe that separate neighboring governments may and do co-exist in mutually beneficial mutually respectful manners when both parties desire to do so, and I am encouraged that this is the case with the Oneida Tribe of Indians and the Village of Hobart, despite any legal disagreements.

What were you doing (employment) previous to accepting the Hobart posi-

I have owned Willman Development Services since 1994, offering community planning, grant writing, downtown revitalization and project management services. My clients have included numerous local (county and municipal) government, tribal government, school districts, hospitals and non-profit organizations in Yakima County throughout Northwest. In the recent years I have reduced consulting services while pursuing a doctorate in public policy with a focus on federal Indian policy, and have also chaired the national organization,

Citizens Equal Rights Alliance (CERA).

Do you feel the Hobart Village Board has a certain agenda they want you to complete? Meaning...are you here to lock horns with **Oneida Tribal Officials over** certain disputes between the Village and the Tribe?

I am impressed with the respect that Village elected officials have spoken of Oneida tribal culture, tribal families and traditions, as well American Indians in general. The only "agenda" of Hobart elected officials that I am aware of is that of their oath of office as elected officials of a local general purpose government who are sworn to provide for the general welfare, public safety and quality of life in the community of those who have elected them. "Locking horns" would be a least desirable outcome, certainly one that does not have to occur when reasonable minds continue to communicate.

"anti-Native American," any more than disagreeing with a city, county, state or federal decision makes me "anti-American." Government decisions are just that: government decisions. My family genealogy research reveals family history origins in Virginia, Tennessee, Kentucky, Arkansas, and Oklahoma and more recently the same pain and stigma as other American Indian families' ancestors. I have had a lifetime adoration of the noble American Indian, and this love of the culture will never leave me. But my affection for American Indian culture is very separate from

government decisions. I chose to move to Toppenish, Washington because it was located on an Indian Reservation. My heart and spirit was truly to be of value and service to tribal members there as well. That was exactly my experience from 1992 until 2000 when the tribal government began to impose tax and regulatory authority over non-tribal members. When I publicly stated that as an American citizen I should never be governed by a government I do not elect, my professional liaisons with the Yakama tribe ceased. This caused an unfortunate loss of rapport and friendship with many wonderful tribal leaders, but I maintain strong friendships with many tribal members on the Yakama reservation and throughout the country.

Tribal governments are federally recognized Congress as purposive governments provided the shield of immunity to specifically and purposefully allow tribal governments to govern their members and their lands in any manner they deem appropriate. Conflict occurs when tribal governments seek to no longer govern only their members, and seek to tax, regulate and govern other American citizens who have their own governments in which they fully participate. As the trend of tribal governments expanding their governance over non-tribal members continues so to continue the conflict. My position on this issue is that non-tribal persons should never be involuntarily governed by a government they do not elect. In this regard good fences make good neighbors, and good neighbors are respectful and supportive of each other. Do you feel your presence will help or hurt Hobart -Oneida relations?

I have more to study and learn about the relations between the Oneidas and

Hobart, but I know that there were many decades when relations between the

Governments were positive, and I would hope that this continues to be the case.

I will be working diligently to be of economic development and tribal affairs help to the Village of Hobart, and would hope that my efforts facilitate ongoing respect for all cultures, and best possible relations among the government entities within Brown County.

#### What is your background with Tribal Affairs?

I have been studying federal Indian policy vigorously through the pursuit of a doctorate degree since 2000, and have 70% of the academic requirements for a Ph.D. completed. I am very familiar with the Indian Determination and Education Act (IDEA-Title 25),

Indian Civil Rights Act

Act (ICWA), and Indian Gaming Regulatory Act (IGRA). More recently I have also been reviewing the Indian Reservation Roads Program (IRR) Federal Air Rules on Reservations (FARR), and the HUD 180 Housing Loan Program. Along with the national organization that I formerly chaired (CERA), I was also very active in opposition to the U.S. Census Bureau's LUCA 2010 program that would have rendered 1,061 local general-purpose governments as "not relevant" in direct contradiction to the constitutional requirements of the Decennial Census. Direct experience with tribal affairs includes experiences with the Yakama, Puyallup, Tulalip, Nooksack and Cowlitz tribes. Indirect experiences include my assistance to local governments and citizens with tribes located in 25 states. I have also had many meetings in Washington, D.C. administrators at the Department of Interior, Bureau of Indian Affairs, Environmental Protection

(ICRA) Indian Child Welfare

More recently I agencies. have worked with the University of Southern California's Center for Risk and Economic Analysis of Terrorism Events (CREATE) on projects funded by the Department of Homeland Security. CREATE assesses and monitors homeland security issues on Indian reservations.

### What are you qualifications for the title Tribal Affairs

**Director?** I have a Masters in Public Administration California State University (CSU) in Northridge, California, received in 1991. I also attended two full years of law school at Ventura College of Law before transferring into the CSU Masters Program. From 1994 through 2007 I was adjunct faculty in the Masters in Public Administration and Masters in Business Administration, and Project Management for City University (City U), headquartered in Bellevue, WA. City U is the 3rd largest university in Washington State but has campuses only in Washington State. City U has campuses in Bosnia, throughout Europe and the

Far East as well. For additional qualifications please see the response to the previous question.

### Rapids School Board votes to change **Red Raiders nickname**

WISCONSIN RAPIDS, Wis. (AP) ~ The Wisconsin Rapids School Board has voted to drop the word "red" from the high school's Red Raider nickname, and allow a committee to create a new mascot based on the new

The move came Monday on a 4-3 vote after about an hourlong discussion.

Board member Anne Lee said she preferred dropping the entire Red Raiders nickname and establishing a new school identity unrelated to American Indians.

Brittany Glaza, the student member of the board, said that, even though some American Indians might be indifferent to the Red Raiders moniker, the opinions of those who are against it must be heeded.

"Even if one student says it offends them, that's worth

(changing it)," she said. But board member Greg Swank said he did not see the

need for a new nickname and that the word "red" does not have to be tied to a specific ethnic group.

'We're talking about offending people ... but taking away the word red, what are we really saying?" Swank said. "That it can't be just a color, it has to be associated with something?

"I'm just a little dismayed (by) all of this."

### BIA nixes Lafayette Co. plan; Kenosha, Beloit bids still pending

MILWAUKEE (AP) ~ An application to develop an offreservation casino in south-Wisconsin's Lafayette County was rejected Friday by the U.S. Bureau of Indian Affairs, a newspaper reports.

But no action was taken on two other major Wisconsin proposals for tribal casinos, one at Kenosha and the other at Beloit, BIA spokesman Shane Wolfe told Milwaukee Journal Sentinel Friday night, and those applications remain pending.

Among 11 applications turned down by Carl Artman, who heads the BIA, was a 6year-old effort of the Lac du Flambeau Chippewa band to open a casino in Shullsburg in Lafayette County, the newspaper reported on its Internet Web.

The decision came as the BIA announced tighter guidelines for approval of off-reservation gambling operations.

Casinos built outside of reservations require approval of the U.S. Department of the Interior, the parent agency of the BIA, and the state's gover-

Under the new guidelines, the farther a casino is from a reservation, the more weight must be given to "state and local concerns," including impacts on tax rolls and on reservation life.

Artman noted in a fourpage letter to Lac du Flambeau President Victoria Doud that the proposed Shullsburg casino would be more than 300 miles away tribe in northern Wisconsin.

"The Department is concerned that approval of this application would not support the option for tribal members to live on their existing reservation and to have meaningful employment opportunities at

the proposed gaming establishment," Artman wrote.

Wolfe refused to say why the BIA took no action on the proposed \$808 million casino for Dairyland Greyhound Park at Kenosha or on the proposal of two Chippewa bands to open the \$200 million Beloit casino.

The St. Croix Chippewa is leading the Beloit effort and has sued the BIA, alleging the rules are being changed to ease the process of denying

applications. Evan Zeppos, a spokesman for the Menominee tribe's Kenosha project, said the proposal was solid even though it from the home base of the would be about 200 miles away from the tribe's reserva-



WASHINGTON - More than a million veterans are in line to share \$349 million in annual insurance dividends during 2008, according to the Department of Veterans Affairs (VA).

These dividends are a commitment from a grateful nation to safeguard the interests of America's veterans, said Secretary of Veterans Affairs Dr. James B. Peake.

VA operates one of the nation's largest life insurance programs, providing more than \$1 trillion in coverage to 7.1 million service members, veterans, and family mem-

The dividend payments will be sent to an estimated 1.1 million holders of VA insurance policies on the anniversary date of their policies. Sent automatically through different payment plans, the amounts will vary based on the age of the veteran, the type of insurance, and the length of time the policy has been in force.

The dividends come from the earnings of trust funds into which veterans have paid insurance premiums over the years, and are linked to returns on investments in U.S. government securities.

VA officials caution veterans about a long-running scam in which various groups charge fees to veterans who are eligible for the dividends. Veterans eligible for the dividends have had VA life insurance policies in effect since they left the military and have received annual notifications from VA about the policies.

Dividends are paid each year to veterans holding certain government life insurance policies and who served

**VA Distributes 2008 Insurance Dividends** holding National Service Life Insurance ("V") policies comprise the largest group receiving 2008 insurance dividend payments. They are expected to receive total payments of



### Wilderness Survival Tools

Specialist-Environmental Protection A canoeing accident resulted in my partner's death and forced me to spend 13 days on a mid-river shoal with one rubber boot, no socks, no food or other provisions other than a baseball cap, handkerchief, pocket knife, field book, plastic bag, and the clothes on my back.

My partner's last words were "let's go for it!" We hit rocks and the canoe capsized; I grabbed an empty gas can as I hit the icy water. I retrieved my ball cap but one boot was lost in the whirlpool. Some distance downstream my feet touched on a small, boulderstrewn shoal some 200 yards from an island. I removed my clothes, put them on rocks to dry, and made a rock platform. The largest boulder was my south-facing headrest.

Uncertainties filled my head. I attempted to sleep, but awakened with chills that evolved into dry-heaves and eventually I passed out. I awoke to sunshine. Relaxing was the key at night and sun exposure was a daytime threat. I wore my cap constantly; handkerchief hung over my ears for sun and insect protection. Black flies and mosquitoes were night visitors but horseflies that attacked during the day were worse. The plastic bag and rubber boot protected my feet from biting insects at night. The words cut into my diary that first day, were: "trial by sun, cold, endurance, will, and insects."

Sleep came the second 100 rocks with no food, the

night under light rain. Relax and drink water became the strategy. The second day, rain was accompanied by strong winds. A rock wall was constructed to block the wind and my gas can was cut and flattened for wind, sleet, rain, and cold protection. My diary for the day was "please". On day 3 the wind switched to west and the rock wall was moved to that side. The wind let up and the skies cleared before dark, allowing me to get the cramps out of my legs and dry my clothes. "Wind" said it all. Day 4, sunny and warm! My urine turned bright orange as protein burn initiated. Energy levels began to fluctuate. The caption was "care, endurance, and will". Day 5 dawned with frost on the rocks. The wind increased and rain squalls followed. Most of the day was spent in the fetal position under my gas can. By late afternoon the rain ceased, skies cleared, and time was spent rubbing cramps from thy muscles. The inscription

was: "Praise the Lord". Day 6 was extremely windy. Reflection, being methodic, and planning for the future kept me going. The day's caption was "this diet is killing me". Day 7 was cloudy and I was awakened by the sound of an aircraft. It flew past to the south. My caption was: "cloud 9 to 0; is my life not worth \$300". Being convinced that others might care was a difficult les-

By day 8, time was an endurance test. "200 hours on

pits" was the caption. Body positioning became ritualized and I seldom left my perch. Killing at least 1000 mosquitoes in each of three positions was a time consumer. As fat reserves depleted, rocks became harder to sit on. Day 9 saw my spirits rise in warm conditions. The caption was: "I have the world's only flow through waterbed".

Day 10 was for soul searching; weaknesses were explored as were strengths. Why did it take 10 days to look inward? The caption was: "food is a four letter word". That night lightning flashed and the insects came in hordes. Day 11 was clear and warm. The caption: "water up three inches, take me home" illustrated my concern for being flooded out.

Day 12 was a watershed. Clouds and strong winds reminded me of earlier tests. I prayed to stay on my shoal for three more days rather than endure 10 hours of precipitation. The rains stopped and the last two days were the easiest of my stay. My comment: "this is the day the Lord hath made" reflected my gratitude. As the sun set on day 13, a plane appeared downstream. It flew overhead, vanished then returned, landed and picked me up. "Food, glorious food" was the last caption of my adventure.


Who is Grandma? She is an elderly lady who works at the Three Sisters Head Start Building.



# **Healthy Weight**

### Week set for January 21-27

Did you make a New Year's resolution to exercise and eat healthy this year? Whether you've already started or are planning to start, Healthy Weight Week is a great time to learn about healthy lifestyle habits. This year, Healthy Weight Week is January 21-27.

Sponsored by the Department of Health and Human Services' Substance Abuse and Mental Health Services Administration (SAMHSA), Healthy Weight Week is an annual, national observance that focuses attention on the importance of staying at a healthy weight. It

is a time to celebrate lifelong health and wellness to prevent weight problems; and encourages people to focus on healthy lifestyle changes instead of dieting.

This is especially important because overweight and obesity is a significant challenge to the health status of Native Americans. Most studies of Native American infants, preschool children, schoolchildren, and adults have confirmed a high prevalence of overweight and obesity. One way this challenge is manifested is in the increasing rates of Type 2 Diabetes, which is a relatively recent phenomenon. For instance, in 2006 the diabetes rate for the Oneida Community Health was 21%. Additionally, it has been estimated that there are a total of at least 3,487 or more diabetics in our community, with at least 1,227 currently not diag-

Start the New Year to learn healthy Lifestyle habits If you are planning to improve your health this year, it's important to understand that a healthy weight is different for everybody. A person's weight is based on many different factors such as genes, muscle mass, bone density, food intake, and level of physical activity. Therefore, it is impossible to have an ideal weight that applies to everyone. So don't get stuck on the numbers you see on the scale. Keep in mind that healthy weight is not just about weight loss. It includes lifestyle, eating habits, and good nutrition, all combined with physical activity.

> With that in mind, strive to get at least 30-60 minutes of moderate exercise everyday. You can do this in fun ways like playing outside with your kids or taking an after-dinner walk with friends or family. Also, try and challenge yourself with 15-20 minutes of more intense activity at least

three times per week. As you become more fit, increase the amount of intense activity you do per day and per week. Remember, exercise should be fun so do things that you enjoy and you'll be more likely to stick with it!

Equally important as exercise, however, is nutrition. There's no doubt about it that to have a healthy body, you must give it all the nutrients it needs to grow and develop. A healthy diet should include whole grain products, vegetables, fruits, low-fat milk products, lean meats, fish, poultry, and dry beans. You also want to limit foods that are high in fat or sugar.

Eating a well-balanced diet provides your body with the energy it needs to function properly. Your own personal dietary habits directly affect your body's well-being and your quality of life. Additionally, maintaining a healthy weight is an important part of self-esteem, because your weight affects your body image, emotions, moods, and physical stamina. A healthy weight can help to reduce your risk for physical and mental illnesses. Remember regular exercise and healthy eating patterns are one of the secrets to good health now and for the rest of your life!

### Preventing Birth Defects in January

Spina Bifida is the most common permanently disabling neural tube defect (NTD) today. It occurs when the spine of a baby fails to close during the first months of pregnancy. According to the Spina Bifida Association, this debilitating defect occurs in 7 out of every 10,000 births the United States. Additionally, 95 percent of NTDs arise in women with no personal or family history. Since birth defects can happen in any family, the Center for Disease Control has named some risk factors including:

- a previous NTD-affected pregnancy
- maternal insulin-dependent diabetes
- · use of certain anti-seizure
- medications
- medically diagnosed obesity

According to the latest research, the risk of neural tube defects can be reduced by up to 70% if all women who could become pregnant were to take a multi-vitamin with the B-vitamin, folic acid. Although this sounds too good to be true, most pregnancies are unplanned. Therefore, the United States Public Health Service folic acid recommendations are:

- Women of childbearing age whether planning to have a baby or not should take 400 micrograms (mcg) or 0.4 milligrams (mg) of folic acid every day
- Women at increased risk should take 4000 mcg or 4.0 mg of folic acid by prescription for one to three months before becoming pregnant

Folic acid can be found in leafy green vegetables like broccoli and spinach, fruits and juices such as orange juice, as well as certain breakfast cereals and other breads or grains with folic acid added. It is important to understand that it is difficult to get enough folic acid from food sources alone. Thus, a daily vitamin with folic acid and a healthy diet are equally important.




