#### **NY Oneidas** get land into trust

SYRACUSE, N.Y. (AP) ~ The federal government will place 13,004 acres of upstate New York land into a trust for the Oneida Indian Nation.

The U.S. Department of Interior says it has given final approval to the tribe's twoyear-old application. The acreage announced Tuesday slightly less than the 13,086 acres recommended earlier this year by the Bureau of Indian Affairs. The Oneidas filed their

trust application in 2005 after the U.S. Supreme Court decided against the tribe in a long-running dispute with the city of Sherrill over unpaid taxes on Indianowned property

The Oneidas had asked for 17,370 acres in trust, which exempts the property from state and local taxes and laws. Government leaders from Madison and Oneida counties wanted no more than about 1,000 acres in

# GTC votes to increase annual per cap payment

The General Tribal Council overwhelmingly approved a per capita plan that increased the current \$800 per capita payment to \$1200 starting in fiscal year 2009 at the May 10 GTC meeting at the Turtle School.

Over 1100 GTC members passed the Oneida Business Committee (OBC) endorsed plan that also included the creation of a yearly deposit of \$1 million in an endowment fund to fully fund future per capita payments. The new

plan is on the heels of an existing per capita ordinance set to expire in 2009.

The meeting was convened due to a petition received by the OBC that called for an increase in the current per capita payment. The petition put forth increases in the annual payment from \$800 to \$1200, \$2000 or \$2500 and an additional one-time payment ranging from \$5000 to \$20,000.

Petitioner Linda Dallas cited attempts to lower the \$5000 and \$10,000 special one-time per capita payments,

approved at an August 11, her petition, but decided to let petition because he knew the 2007 GTC meeting, were the reason for the petioned request. "There had been a movement essentially to reduce that payment and a large number of people in the community were very upset about it, so we made a petition to send a message that if you want to play and try to reduce it we can also increase it. So the petition you have in your packet is because they wanted to play," said Dallas, during her presentation to the GTC. According to Dallas, she was asked to withdraw

the GTC make the decision.

Strong opposition to any large one-time payment was evident after presentations by the tribe's finance area showing drastic repercussions to tribal services and employment if a large payment was

"It's not that I can't use (the money), I know I can, but I feel the services of the tribe are more important than my debt," said Amelia Cornelius, during the discussion portion of the meeting.

Jeff House, Financial Planner/Analyst for the Trust Department, believes the GTC made the best decision possible in creating an endowment for future per capita payments and explains

# **HUD** letter prompts **OHA** to adjust rent By Dawn Walschinski

Kalihwisaks

The Oneida Housing Authority (OHA) received confirmation from the Housing and Urban Development (HUD) offices in Denver that they can change OHA polices to not count the \$5000/\$10,000 per capita payment made in December, 2007 towards income.

The Oneida Business Committee passed an emerresolution Wednesday, May 14 addressing this issue, as well, directing OHA to begin recalculating tenant rents. According to OHA Assistant Executive Director Jason Johnson the process of recalculating the rents will take a couple of weeks.

"We're going to change language and our polices ... to reflect the change," said

The OBC and the OHA will be meeting weekly to complete the task. According to OHA Interim

Director Susan House, OHA

staff began researching the impact on income calculations of the proposed per capita payment in August, 2007. They received a response from Eastern/Woodlands Office of Native American Programs Administrator Kevin Fitzgibbons that OHA had to follow the policies set by the former OHA board to count the one-time-payment as income. OHA staff then contacted the Denver offices of

"We had the conversation (with HUD) in April, we wanted it in writing," said

HUD to see if OHA could

change the policy.

OHA calculated tenant's rents in January of 2008. The change in rent did not go into effect until February for some, March or April for others. Approximately 100 plus tenants faced a rent increase. According to House, the top increase was \$124 a month. Tenants paying a flat rent were not affected.

Oneida housing tenant Yvonne Metivier has been an

The Oneida Hymn Singers are a multi-generational thread connecting Oneida with its past, and its people with its language. Now they will be honored by the National Endowment for the Arts (NEA) as a 2008 Arts National Heritage Fellow in mid-September.

Hymn singers Lee Gordon McLester III, or Gordy as he's widely know, applied for the fellowship and \$20,000 grant on behalf of the group.

The Oneida Hymn Singers produced a six-minute-video about the history of the group and included hymn that had been translated into Mohawk in 1835. The video caught the eyes of the Heritage Award committee.

# Tribe reaches tentative service agreement with Brown County

The Oneida Tribe and Brown County have reached a tentative service agreement after nearly five years with no contract in place.

Terms of the agreement have not been released but in 2003, the last year of the expired contract, the tribe paid the county \$500,000. "The terms will be consid-

ered by the Business

Committee and the Brown

County Board before the end of the month," said Bill Gollnick, Oneida Tribal Chief The Brown County Board heard details of the agreement on May 21. "The County

Executive is going to be out of town, but his staff and members of the county board on the negotiating team will give the board an update on what conclusions they came to," said Brown County Board Chairman Guy Zima. If county board members are satisfied with the presentation on negotiations. the agreement, Zima has asked for a special meeting on May 28 to approve or deny the contract.

According to Zima, terms were discussed in closed session with the county's executive team and seemed reasonable, but felt compromises were made on both sides. "In getting things expedited in coming to an agreement sometimes there are compromises made. You try to understand each other, you respect each other and you try to come to an agreement that is fair. Having anything is fairer than having nothing," he said.

Negotiations resumed between the tribe and county shortly after Brown County Executive, Tom Hinz, took office in April of 2007 as he made reaching an agreement on a service contract a priority. Zima feels the tribe has a more favorable outlook of Hinz and that helped rekindle

"I think the previous administration, the (Karen) Kelso administration, was considered obnoxious by the tribe. I think our present county executive has a better image with (the tribe). The whole county board didn't trust Karen Kelso, I don't know why the Oneida tribe would," said Zima.

Service agreements are entered to compensate local municipalities and tribe for services provided. They are directly related to land in trust that the tribe does not pay taxes on. Services include road maintenance, police and fire protection, and social services.

The Oneida Tribe broke off negotiations in February of 2008 for a service agreement with the village of Hobart after passing a resolution citing a strained government-togovernment relationship with the village.

# **Artman announces Publication of Final** Rule to Implement IGRA Section 20

WASHINGTON

Assistant Secretary - Indian Affairs Carl J. Artman announced that the Bureau of Indian Affairs (BIA) has published final regulations in the Federal Register implementing Section 20 of the Indian Gaming Regulatory Act of 1988 (IGRA). IGRA contains a general prohibition against gaming on land acquired after October 17, 1988, the date the act was signed, which may be overcome if the land meets certain exceptions.

The final rule incorporates suggestions received by the BIA through public comment and the tribal consultation process. The rule will become effective on June 19,

"I am pleased to announce the publication of the final rule implementing Section 20 of the Indian Gaming Regulatory Act," Artman said. "It establishes a formal process with clear standards for tribes to utilize when assessing the eligibility of a site for gaming and clarifies when a tribe may request an opinion from the Interior Department or the National Indian Gaming Commission."

Publication of the Section 20 rule caps a year-long effort by Assistant Secretary Artman to bring predictability, stability and accountability to the Indian gaming marketplace. It joins other tools he has used such as ordering the review of the Indian Reorganization Act fee-totrust process (25 CFR Part 151) followed by the Indian Gaming Regulatory Act and issuance of a guidance memorandum on 151(11)(b) for offreservation acquisitions related to gaming.

The new regulations articulate standards that the Department and NIGC will follow when interpreting Section 20 exceptions to the general prohibition against gaming on after-acquired trust lands and establishes an application process for tribes seeking to conduct gaming activities on lands acquired in trust by the Bureau after October 17, 1988.

Subpart A of the final rule defines key terms contained in Section 2719 or used in the regulation.

Subpart B delineates how the Department will interpret Section 2719(b)(1)(B)'s exceptions regarding: land acquired through settlement of a tribal land claim, the restoration of land for a tribe that has been restored to federal recognition, and the initial reservation of a tribe acknowledged through the Federal Acknowledgment Process.

Subpart C sets forth how the Department will evaluate tribal applications for a two-Secretarial Determination under Section 2719, which provides an exception for gaming to occur on off-reservation trust lands if the Secretary, after consultation with appropriate state and local officials and officials of nearby tribes, determines that a gaming establishment would be in the best interest of the tribe and its

members and would not be detrimental to the surrounding community. The regulation also sets forth how such consultation will be conducted, articulates the factors the Department will consider in making the two-part determination, and gives the governor of the state where the gaming activity is to take place up to one year, with an additional 180-day extension at either the governor's or applicant tribe's request, to concur in a Secretarial two-part determi-

Subpart D clarifies that the rule does not disturb existing written opinions made by the BIA or the NIGC.

The BIA first published proposed regulations to implement Section 20 on September 14, 2000. On January 28, 2002, the Bureau published a notice to correct the effective date section in the proposed rule. In March and April of 2006, the Department held a series of tribal consultation meetings on the development of proposed regulations to establish standards for implementing Section 2719. On October 5, 2006, the Bureau published a new proposed rule to address all exceptions contained in Section 2719 in order to explain to the public how the Department interprets these exceptions. On December 4, 2006, the Bureau published a notice to extend the comment period and make corrections concerning the new proposed

On January 17, 2007, the Bureau published a notice to reopen the comment period for the new proposed rule. The comments received in 2006 and 2007 were considered in the drafting of the

The BIA is the only federal agency authorized to acquire land into trust for the federally recognized tribes and to recommend approval of tribal applications under 25 CFR Part 151 and Section 20.

However, Johnson stated that OHA had to proceed cautiously in order to preserve its funding.

"If you don't follow through, then you're jeopardizing the \$3.8 million grant, then that gets taken away, then we lose all of the services," he said.




Tenants who owe money to OHA will have the overpayment put towards their debt and any extra money will be credited towards future rent.

The annual per capita payment of \$800, which will increase to \$1200 in 2009, will continue to be counted as income as it is paid annually from gaming funds.

live on the Reservation and 40% live off the Reservation. 60% reside in Brown County and 40% reside in Outagamie County. The questionnaire was developed by the Division of Land Management with assistance from the Statistics Program.

The Division of Land Management has two prime directives: 1) Acquire land, 2) Take care of the land with the best interest of the Tribe in mind. With these directives in mind, the Division has developed 3 Management Areas. areas are the FINANCE department which runs all of the loan programs; LAND, TITLE AND TRUST Department which deals with all trust issues, works to put land into trust, contains our Register of Deeds, and our Probate Officer; and our REAL ESTATE SERVICES Department which administers the rental units, the DREAM homes, demolition and clean-up services, and commercial, agricultural, and residential leases. Each of these departments is dedicated to the Tribe's vision of being Care Takers of the

Land. One reason the survey was sent out was to verify our concepts about the needs in our community and the accuracy of our perception of those needs. We learned that we are right when we believe that our community, here on and near, the reservation is a very stable community. Most residents plan on staying in their present homes, and most, if they plan on moving, plan to stay in the area. We, also, saw the very strong bonds of the extended families and the interdependence which exists between the Tribe and fami-

One change we would like to see is a greater awareness

out there, of the encroaching developments from all directions. The survey asked our members if they saw the development coming, and many of them did not notice how much development is coming in from Freedom, Seymour, Green Bay, and Ashwaubenon. This development is impacting the family farms by raising land values and eating up farm land.

Then, we would like to have members visualize what the homeland would look like if we had 50,000 residents here, or even 30,000. A small group said the reservation should be home to 50,000 and more residents. By visualizing the reservation to look like a suburb, and understanding that there is existing housing on the reservation's east side which is in a developed section of the City of Green Bay; we hope those members will see that buying existing homes which are on sewer and water and are near to grocery stores; is a better action than running new sewer and water systems into remote areas of the reservation.

Our main direction, as we feel was re-enforced by the survey, is to continue to acquire the land, to continue to protect the rural environment, continue to offer DREAM homes, and to maintain/regain our natural resources.

the benefits of using an endowment for funding future expenses of the tribe.

"An endowment is a fund usually set up for a specific purpose and the idea is that the principal is never invaded. Income or a portion of the income generated from the endowment is used to fund a goal. Endowments are investaccounts typically invested in cash, stocks and bonds. Professional money managers would be hired to manage the investment and they would be given paramethat the endowment is successful," he said.

The new per capita plan will be in place until 2013. A long term plan is hoped to be in place before the newly adopted plan expires.







"Standing Strong... All Day Long" is the logo behind Standing Rock energy drink, a product that was recently developed by Red Cloud Food Services (RCFS). RCFS is a Native American owned food service company out of Illinois that specializes in providing food products to the US Military.

RCFS Chairman Robert Harrison began Red Cloud Incorporated, the predecessor to the current RCFS, in the early 90's as a manufacturer of shipping supplies for other food producers. In 1998 he began to produce his own line of food products and began selling to casinos across the region. He is also a Standing Rock Sioux.

It wasn't until after September 11, 2001 that he began to sell his products to the US Military.

"I ended up in getting into the military factions...as an entrepreneur I saw that as the focus and as a native American business we thought we could gain some ground [and] try to use our background as a door open-

er," Harrison said.

RCFS has been certified by the US Small Business Administration as a SBA 8(a) BD program. This certification, along with Small Disadvantaged Business program certification it also received has helped RCFS by providing opportunities only available to businesses that qualify for the 8(a) contracts.

Although Harrison acknowledges the certifications and proudly prints them on all of his business cards, he knows that alone will not sustain businesses profitabili-

"What sustains the business as an entrepreneur is your product has to be very good. And it's got to be what the new trends are; the all natural, whole wheat [and] go green areas with packaging the products," Harrison

In addition to the new line of energy drinks produced last fall, RCFS also produces food service packaged sandwiches, paninis, grab and go

bakes (similar to a hot pocket), and shredded meats which it sends overseas to help the US military feed our troops abroad.

RCFS has been a supplier of the US armed forces since

RCFS is a \$30 million company with a good portion of its annual revenue stream coming from military sales.

Harrison is proud to be a supplier for the military and takes pride in telling people that he currently employs on his staff a Lieutenant Colonel, a Captain and a Sergeant Major all of which are now retired from the US Army.

Harrison also emphasizes the fact that "we are a true manufacturer, a true Native American manufacturer. We're from a-z...we're not a broker."

This means that RCFS produces, markets, sells and ships all of its own products. They own everything involved from products to personnel. They do not buy any outside products to repackage and resell as their own.

Recently, brought onboard Thomas Wilbur, an Oneida Tribal member, as RCFS's western region Director of Sales. Wilbur is the founder of Thomas International Incorporated, a company that exports commodities world-

Harrison, Wilbur and sev-

eral other RCFS executives recently visited the Radisson Hotel and Convention Center to provide product samples to the Oneida Casino, Radisson and Oneida food services in an effort to promote its products. In addition, RCFS also invited anyone interested in trying their products to participate in the sampling.

Harrison said the reason for the visit was to help promote a "Buy Native - Native to Native" initiative.

RCFS is also a co-packer, which means they package under more than one brand name for sales in other mar-

Currently RCFS sells to the food service industry only, however there are plans in the works for an on-line store to sell to the average consumer.

"We might set-up a website...within the next 90 days...that they could go into and they could buy our products," Harrison said.

So what does Chairman of this \$30 million corporation attribute his success to?

"I started this company...because I didn't want to work for anybody. I wasn't the smartest guy, but I had a vision and I had endurance and over the years, my vision was to grow and as we're growing, each time, I'm finding different things that I learn.

I do remember vacations we took to Wisconsin when I was a kid We would stay in DePere with my aunt and uncle, Mary and Jasper John I remember the little Taverns we'd visit, the Polka music, and of course, the Cheese shops. Unfortunately, I've never made it back to Wisconsin.

# **BC Forum**

On Saturday, May 10, 2008, the General Tribal Council (GTC) met to discuss and take action on a petition that asked the GTC to consider approving a second onetime per capita payment in amounts ranging from \$5,000 up to \$20,000 per person, and a request to increase the current \$800.00 payment up to \$2,500 annually. I would like to provide you an overview of the action GTC took on May 10, as well as share some thoughts with you about how the meeting was conducted.

With excellent support from tribal staff, who I thank for doing a tremendous amount of work in a short amount of time, the Oneida Business Committee (OBC) was able to review a thorough analysis of the requested per capita amounts and in turn, provide the findings to you, the membership. Each tribal member on the enrollment mailing list received the information about the petitioned requests, and it was shared that the tribe could not realistically afford to make another large payment without directly affecting services or jobs.

Recognizing the veracity of proposed petition amounts, OBC authorized workgroup, comprised of OBC members and staff, develop and recommend a second option to the GTC for consideration. The second option was a proposed \$400 increase to the current annual per capita pay-

ment (from \$800 to \$1,200) starting in 2009, as well as a request for GTC to establish an endowment (savings) to munication plan and coordiprovide a source of funds for future per capita payments that may be recommended by GTC. I thank the GTC for passing the second option and I believe the message received is that GTC continues to look toward the future and will continue to make decisions that are in the best interest of the Nation as a whole.

The GTC is also to be commended on the manner in which the business was conducted. It was a difficult environment to conduct business with more than 1,500 Oneida citizens engaged in doing

## **SECTION TWO:** Reporting and Taxation of **Payments**

- **1.** All payments are subject to federal income tax and may be subject to state or other applicable taxes.
- **2.** All payments must be reported as income and may affect eligibility for entitlement programs.

- **4.** Each payment will have a 1099-MISC tax form issued. This includes payments that are attached for child support and/or tribal debt.

- **6.** Mandatory Federal Incom Tax Withholding is required on payments as indicated on page 57 of IRS Publication 15–A. For 2008, payment amounts totaling over \$8,950.00 are subject to this withholding.

# Judicial review update understanding citations

updated to include all cases from 2006 and 2007. Once you are logged onto the Intranet, scroll down to the Judicial System, tab over to Appeals Commission, and then stroll down to the Oneida Nation Reporter. Here you will find instruction on how to read the Oneida Nation Reporter citations. For example; 9 O.N.R. 2-25, 26 (03-TC-092, 4/28/03), the first number in the citation (9) refers to the volume the Oneida Nation Reporter (O.N.R.) in which this case/holding can be found. The second set of numbers (2-25) refers to the exact page location of the case in that volume. This set of numbers gives the chapter number and the first page of the case. The last number in the citation (26) gives the page number where the particular holding of the case can be found. Thus, the sample citation refers to a case holding that can be found in Volume 9 (2003) decisions, chapter 2 (trial court cases), page 26. The numbers and dates in

Reporter Cited Cases is an alphabetical listing of all cases (Oneida Appeals Tribal Judicial System, other Tribal Cases and Federal/State courts) that have been cited in decision by the Oneida Tribal Judicial System, along with a brief description of the disposition of the cited case.

A List of Cases is an alphabetical list of all cases and the decision related to each case (Initial Review, Trial Court, and Appellate Court) by party

The purpose of the Oneida Reporter Topical Index is to facilitate research. The index is not a substitute for reading the cases, as even a small change in the facts may affect the relevance of a particular holding to another case.

The Topcial Index consists of the case holdings/rules of law from the decisions in all volumes, arranged by subject matter. Subject matter headings are listed in bold print, sub-headings are italicized. For example, holdings from cases involving employment terminations can be found under the topic: Employment after the starting page of the decision, is the page upon which the applicable holding appears. The indented paragraph is either a quote or paraphrase of the holding of the court on that particular subject matter. Where multiple cases have reached the same holding, a mere sample of such cases may appear, rather than every single case which essentially says the same thing on a particular subject matter. The brief summaries are intended to aid with research and are no substitution for reading the entire

The Oneida Tribal Judicial System also submits our decisions to Versus Law. Versus Law is a for-pay subscription service on the Internet which allows users to search for cases from federal, state and other tribal decisions. You will need to subscribe to Versuslaw.com for a monthly fee. Our decisions are sent over to Versus Law soon after those decisions are made pub-

# **Seatbelt** safety rewarded

May 19th – June 1st is the National "Click It or Ticket" Campaign. As part of the Oneida Nation's responsibility to protect our people, the Injury Prevention Program and the Oneida Police s Department are teaming up to raise awareness of the importance of safe driving practices for the Oneida community. During the "Click It or Ticket" Campaign OPD and the Injury Prevention Program will be involved in activities to encourage proper seatbelt use. The Oneida Police Department will be handing out incentives to those who are in compliance with the seatbelt law. The Injury Prevention Program will be conducting observational surveys at different intersections of the reservation to monitor seatbelt usage. OPD and the Injury Prevention Program will also conduct classes in the Oneida Tribal Schools in support of this campaign. The purpose of this community outreach is to keep our community safe, as well as prepare tribal members for their holiday travel. Many other local law enforcement agencies are involved with this national campaign in our area to raise overall public awareness.

Wisconsin's Primary Seatbelt Law requires that all children under the age of 8 be properly restraint and that you can be pulled over by an officer observing an unrestrained child and could cost you anywhere from \$148.20 to \$249.00. The Secondary Seatbelt Law is enforced when you are pulled over for another violation and you or your passengers are not properly restrained. Following the law is important but the safety and well-being of our community and its members is our main concern.

Summer is quickly approaching and people are starting to make their plans for the Memorial Day weekend. Memorial Day Weekend sparks the summer travel season and the National Highway Traffic Safety Administration (NHTSA) ranks Memorial Day weekend as one of the deadliest holidays for traffic related deaths. Historically, approximately 500 people are killed each year in automobile accidents during the Memorial Day weekend, half of which are the result of alcohol related crashes. Please exercise caution and your best judgment when traveling this weekend.

and then fringe benefits. In my budget, I only have one line for each

> Secondly, when creating a budget, the dollars a program is expected to bring in is put in parenthesis and represents a negative number. Therefore, according to the LIES, the Kalihwisaks is responsible for collecting money for employee testing and incentive, and for absorbed fringe benefits. This is not a duty my department has been charged with.

Third, when you add up the employee incentives and the employee testing correctly, you get 458,768. When you do it incorrectly, that is as all Fringe Benefits positive numbers, you get 799,592, 833,029. not Moreover, 833,029 does not fit into the first number of \$365,029, which I assume is intended to represent my total budget.

Finally, I have to wonder why my department was singled out for such generous employee incentives. The amount dwarfs my actual payroll and budget.

I know there were a couple of real numbers in the LIES, because the best LIES always have a grain of truth.

Yes, I have \$18,500 in my expense. business

\$17,000 increase was based on a quote I had gotten for a website for the Kalihwisaks, a website where we could do more than post the print version of the paper. We are working with the OBC and Management Information Systems (MIS) department to make this website a reality. This will be a one time expense.

One has to question whether the people spreading the LIES are either unable to read a budget, or have no problems getting creative with budget numbers.

Mixing fact with fiction only confuses members of the GTC and breeds suspicion and contempt. The truth is there are areas where the tribe could cut down on wasteful spending; it's just a shame it wasn't brought forward in an honest manner.

Incontinence of Urine is a major problem that, when serious, can negatively affect the quality of life of many women!

It is estimated that between five and 55 percent of women are affected according to different age groups.

The costs for diagnosis and treatment are staggering and are close to 30 billion dollar a year!

Various factors seem to play a role: smoking, obesity, previous pregnancies and deliveries, pelvic surgery can affect the occurrence of incontinence.

The evaluation of the degree of incontinence and its effect on the woman's activities play an important role in the decision making process that will lead to an effective therapy and treatment

There are several types of incontinence;

One, called genuine stress incontinence occurs when the loss of urine is caused by sneezing, coughing, lifting or other physical activity.

This type of incontinence can be due to poor muscle support and or poor bladder closure muscle tone.

Overactive Bladder and urgency incontinence are often caused by a bladder that is over sensitive and leads to urgency and leakage before the patient can reach the bathroom.

Many women suffer from mixed urinary incontinence

due to both previously mentioned types of inconti-

Before a treatment is instituted a very thorough history with incontinence questionnaire is taken.

A clinical examination in the urologist's office may reveal some indication as to why the incontinence is occurring but often additional tests are required: poor muscle support can often be diagnosed right in the urologist's office.

First we like to make sure there is no bladder infection, stones or tumors present.

Then Urodynamic studies where the bladder capacity and pressures are measured and bladder X-rays are often ordered.

These can be performed at the Oneida Community Health Center. Incomplete bladder emptying if present also needs a special work up!

The treatment can consist of oral medication, pelvic muscle therapy, urethral bulking and even surgery.

Whatever treatment is used a complete cure can never be guaranteed; major improvement is often the end result!

Usually the less invasive or medical treatment is tried before surgery is contemplated.

# Speech and Hearing Awareness Month

Hearing loss is a common problem due to the combined effects of noise, aging, disease, and heredity. One in three people over the age of 60 have hearing loss. Whether a hearing loss is small or large, it is a serious concern. Hearing problems can make it hard to understand and follow a doctor's advice, to respond to warnings, and to hear doorbells and alarms. If left untreated, problems can get worse.

How Do I Know if I Have a Hearing Loss?

You could have a hearing problem and may need to get your hearing checked if you:

- Have trouble hearing over the telephone,
- Find it hard to follow conversations when two or more people are talking,
- Need to turn up the TV volume so loud that others complain,
- Have a problem hearing because of background noise,
- Sense that others seem to mumble, or

 Can't understand when women and children speak to you.

What should I do?

You can call the Oneida Community Health Center at, 920-869-2711, to schedule an appointment with an audiologist. An audiologist can measure your hearing. You do not need a doctor referral to schedule an appointment. The appointments generally last 15 to 30 minutes, and there is no charge to eligible tribal members. Hearing better is worth the effort, so call to schedule your appointment today.

# **Rockets Over Sheboygan**

As reported in previous Thunderhawk Times articles, this year several ONHS students got a chance to go down to Sheboygan to launch two 6' 4" rockets. The students were supervised and advised by two ONHS science teachers, Becky Nutt and Susan Hayes.

"Actually," Nutt said, "it was very clever how they [Callahan's team] did it. They put the egg inside a tennis ball container and surrounded it with glue."

Mills' team was not quite so successful. They surrounded their egg with bubble

# Joining the Mother Earth Water Walkers in Oneida

Special to the Kalihwisaks On Mother's Day, I was called to join a caravan of Anishinabe people who were walking around Lake Michigan from Ontario, Canada. After some brief thought about my schedule for that day, I asked my youngest son to join me on this walk. The walkers needed both men and women to join the walk: the men to stand guard and carry the eagle staff, and women to carry the water. The "water walkers," as they're affectionately called, are on a mission to raise awareness about the pollution in the Great Lakes.

The head water walker, Josephine Mandamin, is from the Wikwemikong Unceded Indian Reserve No. 26 located on the Manitoulin Island in Lake Huron. Her people are keenly aware of the condition of the Great Lakes and other waters like rivers and underground water. On Wikwe Island, there are three different tribes, the Ojibway (Faith Keepers), Odawa (Traders) and Pottawatomi Keepers). Their alliance is known as the Three Fires

Confederacy.
Grandmother Mandamin is one of the main grandmothers who inspired the "Mother Earth Water Walk." They walked around Lake Superior in 2003, around northern Lake Michigan in 2004, Lake Huron in 2005, Lake Ontario in 2006 and Lake Erie in 2007. This year, they began their walk on April 22nd from Manistee, Michigan, to go around the southern portion of Lake Michigan. They walk

an average of 50 miles per day with a support team.

Other community members had joined the walkers before dawn and walked with them up to Kaukauna. Wisconsin. My son and I met up with the water walkers on County Road U, about 17 miles south of the Parish Hall in Oneida, just as they were leaving Kaukauna. As walkers joined the caravan, they were smudged with cedar and cleansed of all other worries except the mission of the water walk. The women were instructed to wear long skirts and be mindful of the women's teachings. The men were instructed to carry the eagle staff high, and protect the women as they carried a copper pail of water down the road. The Anishinabe people always point out how important it is for men and women to work together. They tell young men and women that they each have their own roles and responsibilities not only for themselves, but for others, including the earth and the environment.

Throughout the day, several groups of people joined the water walkers including: Oneida, Ojibway, Hochunk, Menominee, Navajo, Kwaguilth, and others. We took turns walking the eagle staff and water pail for about a quarter of a mile, and then passing the staff and pail to another pair of walkers. As each pair of walkers passed on the staff and pail, they jumped into the waiting vehicle and drove ahead of the caravan to wait for their turn

By the end of the day, the tion and in full support of

water waters and local supporters carried the eagle staff and water pail down some trails through Pamperin Park, under Hwy 29, to old Shawano Avenue. They ended their walk for the day near the United Health Group on County Road J in Howard, Wisconsin, about 8 miles north of the Parish Hall in Oneida.

The people showed warm and wonderful hospitality to the walkers as they journeyed through the Oneida reservation. Some local residents came out of their houses to ask the water waters what it was all about. Later, a dinner, which included Oneida Corn Soup (of course), was served to the walkers and their supporters at the Parish Hall. The entire Canadian entourage received lodging for Sunday night in one Oneida home on County Road J.

The water walkers were very pleased with the support and encouragement from the Oneida community. On their website, motherearthwaterwaters.com, on the "Live Updates" page, they wrote: "Thanks to all the members of the Oneida Nation who helped us walk through Green Bay, the food and lodging was excellent."

My thanks also go out to Bev Scow, who coordinated the hospitality, walkers, and dinner on Sunday, May 11th. Many thanks, also, to Caterina Delgado-McLester who opened her home to our Canadian visitors. Many thanks, also, go to the women and to all the young men who joined the walk without question, and in full appears of

Grandmother Mandamin's mission and journey.

I gave Grandmother Mandamin a big hug, and told her it was an honor to walk with her on Mother's Day, the day originally designated as a call to unite all women against war. In the United States, this special day was started by Julia Ward Howe as "Mother's Day for Peace." The water walker's war is against big corporations, and their mission is to save fresh, clean water for future generations. The corporations are polluting the Great Lakes and nearby waters with chemicals, disease-causing organisms, exotic species, mercury, and other harmful substances.

Corporations are also trying to bottle and sell spring waters, even as local communities protest.

Last Sunday, it was appropriate that men and women gathered together to walk for clean water and environmental justice on Mother's Day.

# Getting to know your neighbors, meet the Begays

James (Navajo) and June Begay (Oneida) have lived on Ray Road for 16 years. Previously they lived in California for more than 40 years. Their children include: James Jr. (Oneida), Dennis (Deceased), Candace (Utah), Susan (Arizona), Carla (California), and Joseph (Alabama). They share their home with two cats named Daisy, 9 and Sissy, 7.

June grew up in Oneida. Jim was born in New Mexico, but grew up in Arizona. While growing up, June wanted to be a nurse. Jim always knew he would join the service and be a Marine like his older brother. He tried to enlist when he was 16 but had to wait a year until he was 17. June's first job was as a secretary to the Head Nurse and Chief of Staff at Fort Defiance in Arizona. Jim's first job was as a Marine. He started his service career in 1944 at the end of World War II as an infantryman; he also served as a tank driver in the Korean War and as a tracked vehicle mechanic in the Vietnam War. Jim was honorably discharged in 1966. Both June and Jim retired in California. June retired as a post office clerk, and Jim retired as a Mechanic/Welder. June's father worked as a molder; Jim's father ran a horse and sheep ranch. Both of their mothers were housewives, a term used in that era.

Jim's favorite hometown memory is swimming in a creek with a waterfall in Arizona. It was the local

hangout during his youth. rable vacation was their first June remembers ice skating on Duck Creek in Oneida with her cousins; they used to keep a fire going to stay warm. Jim was an avid boxer in high school and the service.

June's favorite toy growing up was a great big doll she had gotten from "Santa Claus" when she was very young. Jim's favorite toys were tops and windmills he carved himself. June's most memorable birthday was when she turned 21 and could vote. Jim's was turning 18 while stationed in Okinawa and China at the end of World War II.

What was a typical Saturday like as a young adult for June and Jim? June remembers Wednesday ladies night out. She went out with a bunch of her friends for drinks and dancing and remembers the group always having a table full of free drinks sent by admirers. Jim was in the service and his Saturday night out was called weekend liberty. There was a place called the Indian Center off base that he enjoyed going to where he could meet and visit with fellow Native American service personnel and civilians. It was there that he met Ira Hays. Ira Hays gained fame when he, along with four fellow Marines and one Sailor raised the US flag over Iwo Jima (reference Flags of our Fathers). The Center provided food, beverages, and entertainment. Occasionally there would be a USO show or live western

The couple's most memo-

trip to Alaska for their son Joseph's wedding. The farthest June has ever traveled from home besides Alaska was her move to California to be with Jim when he was getting out of the service.
