## Group sues Interior Dept. over Oneida land trust decision

SYRACUSE, N.Y. (AP) ~ A citizens group filed a federal lawsuit Tuesday challenging the U.S. Department of the Interior's decision to place 13,004 acres of upstate New York land into federal trust for the Oneida Indian Nation.

Upstate Citizens for Equality contends the federal agency does not have the authority to place the land in Madison and Oneida counties into trust, a move it says vio

## Hobart injunction denied by Brown Co. judge

The recently signed service agreement between the Oneida Tribe of Indians of Wisconsin and Brown County has triggered legal action by the Village of Hobart. The Village was seeking an injunction on the section of the agreement as it relates to primary police coverage of certain parts of Hobart. That injunction was denied in court on Wednesday, June 18 by Judge Marc Hammer.

Although the village did

not receive the injunction, they will be back in court on October 27 to further argue the merits of the agreement.

In the service agreement, the Oneida Police Department was given primary responsibility to a 1700 square acre section of the Village roughly from the intersection of Highway 54 and 172, west to near where the Town of Oneida begins.

Hobart Village President Rich Heidel is leading the campaign for the injunction and sites various issues the

Village has with the agree-

"We've got a number of issues with it. In no particular order, it was negotiated without the benefit of Hobart being at the table at all. It does impact what are the jurisdictional boundaries of Hobart and what I think is not only illegal and unconstitutional, but also short sighted and potentially dangerous."

Village Administrator Elaine Willman also believes there are some inherent flaws with the service agreement

and she is working to do what (Hobart's)." she believes is in the best interest of the residents of Hobart.

"We have an incorporated boundary and for someone to just artificially create another internal boundary within that sets up very uneven and confusing law enforcement jurisdiction, and I believe there is no statutory authority anywhere in Wisconsin for piecemealing a municipality. That's what we think is the danger to our citizens and to the officers, (Oneida's) and

Heidel and Willman both that the County Executive, Tom Hinz, has over stepped his authority as the county CEO in negotiating the coverage of police protection within that 1700 acre area of Hobart.

"For the county executive to involve himself in this, let alone execute the agreement; frankly he's overstepping his

## Goodwill opens superstore on Green Bay's west side

Goodwill opened its third store in the Green Bay area on Thursday, June 19, and is opening its doors to the community with meeting spaces, work services and the Harmony Cafe'. According to President and

CEO of Goodwill Industries of North Central Wisconsin Bob Pedersen, their organization has been progressing towards the new store's lay-

"When we realized this opportunity was available with this old Best Buy store, we thought, gee, this is a good chance for us to put this minicampus concept together and to cluster a bunch of services around the retail component," said Pedersen.

Along with the 33,000 square foot store, the location will house the Financial Information and Services Center (FISC) which offers credit counseling, Beyond Boundaries of Autism, Prospera Credit Union and

Harmony Cafe – a non-profit coffee shop.

Harmony Cafe Program Director Shannon Kenevan stated his program focuses on arts and culture, diversity, and leadership development.

The cafe offers computers, wireless internet, and a space to relax and meet with others or listen to live music on Thursdays and Saturdays.

In addition, there is a large conference room and some smaller meeting rooms available for community groups or individuals.

"I would hope there would be a lot of folks from the Oneida Nation and from other groups and people from this community who would come into this space and say, 'boy, I would like to do this type of program or that type,' and we can help make that happen," said Kenevan.

## Veterans Memorial benefits from youth mission trip

"They nick-named us the yellow shirts."

For those of you who attended last years Oneida Powwow, you may remember the youth group from Indiana wearing the brightly colored yellow shirts that were lending a helping hand during that weekend's festivities.

Laura Brady, Youth Minister for the Pleasant View Church of Christ in Angola Indiana, organized a trip to Oneida last year and has done so again this year.

The group arrived in Oneida on June 17 with 13 children and four adults. Their goal this year was to help with some landscaping around the Oneida Veterans Memorial.

"This year when I called...the veterans said, 'hey how about doing some landscaping, maybe a couple benches?' So we're doing that now," Brady said.

The youth group raised the

money doing various fundraising activities since last year.

"They started raising money in November with carnivals and cookouts. This year we raised about \$7000," Brady

The money is used to buy food, hotel rooms, supplies for the project and gasoline.

"Last year we brought five vehicles, this year we squished into three. We didn't buy any supplies (in Indiana) because

we couldn't bring anything."

Brady herself is an Oneida tribal member with her grandmother being full-blooded and her mother being raised in Oneida.

"So when we talked about a mission trip I'm like, 'we're going to Oneida, we're not going anywhere else."

The mission trip will last through Sunday, June 22 and Brady said both she and the kids hope to return to Oneida next year as well.

reiterated the position of (OBC), we will email the being based on facts, not rumors.

"If there is a posting or topic about specific people than we better have physical backup (information)," he said.

While both venues claim to allow uncensored or edit posts by visitors, the Oneida Grapevine offers a more proactive approach to dispersing information.

"The Daily Digest is a mass email sent out that members can receive and if anyone has questions for the Oneida Business Committee

questions to the OBC members and they give us answers back and then we post them," said Elaine.

The CIRCL blog has established a link to another website for candidates for the July elections to post their platforms and credentials.

The Oneida community seems ready to embrace this new media as the CIRCL blog has had over 1200 visitors and the Oneida Grapevine has had over 1000 posts. Both appear ready to continue utilizing their vehicles to tackle future issues within the tribe.

bounds," Heidel said. "It would be no different if he had carved out the Three Sister's community from the City of Green Bay and not involved the city police department, not involved Mayor Schmitt, not have included the entire city, but just arbitrarily and unilaterally carved out a portion of the city of Green Bay."

The logistic and pragmatic concerns for the officers patrolling the streets are also of concern to the Village.

"There's really a pretty good relationship between Hobart Police Department Oneida Police Department. The on the

ground officers get along quite well. They know their boundaries; they know their respective rolls. Now that's going to be affected deeply by this," Willman said. "I don't believe law enforcement has ever been the subject of a service agreement in the past and it really has no place in one. That would be done in an inter-governmental agreement not in the nature of reimbursement for services. It's an inappropriate subject for a service agreement."

Although Hobart has filed an injunction against the Oneida - Brown County service agreement, that doesn't mean that there is not room

for other options in regards to cooperative coverage of police protection.

"I do think it's in the realm of possibilities that if there was some type of an intergovernmental agreement, not a service agreement, between the tribe and the village that carefully defined the areas of responsibility and in which the logistics of dispatch and coverage were ironed out and a waiver of sovereign immunity from the tribe for purposes of this agreement then theoretically it is in the realm of possibilities," Heidel said.

Attempts to reach Tom Hinz for comment were unsuccessful.

into trust, a move it says violates the New York state constitution.

"The only time the federal government can take land away from a sovereign, existing state is when that state gives the federal government permission. The only exceptions are very narrow, such as the eminent domain law for federal projects," said David Vickers, executive director of the 8,000-member organiza-

"Taking land for Indian tribes is not something that New York has granted permission for the federal government to do," Vickers said.

New York state and the two counties have said they will file a joint lawsuit to contest the decision before a Thursday deadline.

"There will be constitutional challenges, challenges to the statute and the application of the statute in this case, and there will be challenges to the decision as being arbitrary and capricious and otherwise contrary to the law," said attorney David Schraver, who represents the counties.

The Oneidas had no comment on UCE's lawsuit, said spokesman Mark Emery.

In a long awaited decision, the interior department announced last month it would put 13,004 acres of land into trust for the Oneidas, a status that exempts the land from local and state taxes and regulations but makes it subject to most federal laws. The land amounts to about 1 percent of each county's total acreage.

The Oneidas had sought 17,370 acres and the counties argued for no more than 1,030 acres of trust land.

The Oneidas once possessed about 300,000 acres within their reservation, nearly all of which was illegally conveyed to the state without federal approval.

The trust process dates to 1934 Indian the Reorganization Act, which was meant to help redress the loss of millions of acres of tribal land nationwide in the

But UCE argued that the 1934 law depends on an over-broad reading of the Indian Commerce Clause, which it said in the lawsuit cannot be interpreted as giving the federal government the power to strip a state of its sovereign right to govern land within its own borders.

Additionally, the 1934 law unconstitutionally shifts legislative authority to an executive branch agency, UCE

The lawsuit filed in U.S. District Court also challenged whether federally recognized Representative and Chief Executive Officer Halbritter is the "rightful governing authority" of the Oneidas.

"We think Ray Halbritter is the wrong person to be in the chair asking for the land to go into trust anyway. Even if you think that the federal government does have the right to eliminate portions of New York from being New York, they can only do it if


in New York. The interior department decision was also challenged Tuesday by the Stockbridge-Mohicans of Munsee Wisconsin, who have a claim to 3,100 acres in Madison County, their ancestral home. In a lawsuit filed in federal court in Washington, the Mohican tribe contends the interior department is giving away land that is part of their reservation created by the federal government in a 1788 treaty.


Two other citizens groups the Central New York Fair Business Association and Citizens Equal Rights Alliance - joined by individual state and local lawmakers, have already appealed the decision to the Interior Board of Indian Appeals. But the IBIA dismissed the appeal, ruling Monday that it did not have jurisdiction to review the decision.


The federal government holds over 66 million acres in trust for about 350 tribes, according to U.S. Bureau of Indian Affairs.

## **US 41 expansion creates** new income for Oneida tribal member

## WisDOT reaching out to minority businesses

A newly formed Oneida landscaping company has landed a contract connected to the biggest road construction project in northeast Wisconsin's history. Ron McLester started Ron's Cut & Trim earlier this year and now finds he's playing a role in road building.

"He was very excited to get the work," said Ron Montano, Disadvantaged Business Enterprise (DBE) Support Engineer for the Wisconsin Department Transportation's (WisDOT) US 41 expansion project.

In the fall of 2009 work will begin in Winnebago County and in 2010 in Brown County on the reconstruction of 32-miles of the highway, expanding it from four to six lanes. It's a \$835 million project and WisDOT is reaching out to minority and womenowned businesses to help them become DBE certified. The federal program's goal is to increase participation for disadvantaged businesses on

highway projects, by leveling the playing field and breaking out contracts for these firms to bid on.

In McLester's situation, he's been awarded a contract to maintain four properties in the town of Oshkosh that WisDOT purchased as part of the expansion project. While not DBE certified yet, his firm does qualify under the state's Minority Business Enterprise (MBE) designed to also foster growth of minority businesses. Montano says McLester has applied for DBE certification and expects Ron's Cut & Trim to soon join the growing list of 48 other firms expected to compete for the millions of dollars of work the US 41 expansion will pump into the local econ-

"Once we see how his company handles this work we will consider adding more properties to his contract," said Montano.

Montano says the state is dedicated to reaching out to potential DBE qualified firms and bringing them into the process. So all minorities can share in the work the US 41 project is creating in Wisconsin.


#### **Honor the Elder** Luncheon

## **Legislative Update**

#### **Presidential Promises**

Barack Obama came back to the Wisconsin area this past week fulfilling a promise of a return visit near the end of his campaign tour. His policies and plans of action for change in the Nation's economy are simple, yet compelling, and his manner of getting things done is laudable. As I sat and listened to his speech, I kept thinking about how Oneida people would benefit from his planned tax credits, education credits, lower cost for pharmaceuticals and co-pays, and plans for every person to be able to get health insurance of some kind. His plan to pay for all these positive changes is to eliminate the tax benefits that large corporations use to develop their businesses overseas and to decrease the tax breaks currently enjoyed by those making \$250,000. To show how these benefits would actually impact the people, he presented a scenario of a young couple with two children living on \$37,000/year, and how they have to struggle to make ends meet. This interview was very impressive and left me with so many thoughts, as did the elders who spoke up saying they have to pay \$600 or more out of their own pocket per month to buy their medicines. If they are on a fixed income already, this must be

devastating for them. At first, I thought of the benefits those living on the reservation would receive should any of Obama's plans come to fruition. Then I started thinking of all those members who live off the reservation and how they may be impacted. It is difficult to know exactly what this impact would be without having a census of our people to find out where they live, how they live, the size of their family, household income, etc. This is one of the issues I would like to address in the next term if I am re-elected.

## **National Legislation**

#### H.R. 2419 and 6124 The Farm Bill Reauthorization

The Farm Bill is an expansive bill authorizing all agriculture programs including commodity, conservation, and nutrition programs for the country. Specifically for tribes, the bill contains a number of important provisions such as increased funding for the Environmental Quality Incentives Program (EQIP) which helps to conserve land and water resources. The Farm Bill would also improve outreach and technical assistance programs that tribes or tribal members could access.

On May 21st, the President vetoed the HR 2419, the Farm

Bill, over concerns related to crop subsidies to high income individuals. On May 22nd, the House and Senate voted to override the veto of President Bush on HR 2419. However, in a clerical error, HR 2419 was missing an important section of the bill related to trade. Thus, the House and Senate have passed a new bill, HR 6124, to incorporate all of the provisions. It is expected that President Bush will veto this version of the Farm Bill in the next couple of weeks, and then the House and Senate will again override that veto.

## Tribal Legislation

The Legislative Operating Committee is winding down the term with the projected completion of a new Oneida Housing Authority Law and a child support law. The new Oneida Housing Authority law proposes to bring the Authority under the Tribal management structure in an effort to provide greater accountability and oversight. The Child Support law deals with paternity issues, location of parents, enforcement of

child support orders, collecting child support payments from parents legally obligated, and ensuring that both parents financially support their children. LOC is in the final drafting stages of this law and it will be presented to the Business Committee by the end of June for approval. ## Burke set to begin tenure on Wisconsin's **Burial Sites Preservation Board**

Corina Burke, Tribal Historic Preservation Officer, been appointed by Governor Jim Doyle to the State of Wisconsin Burial Sites Preservation Board and will serve a two-year term.

The current Burial Sites Preservation Board is made up of nine members and is responsible for determining which Indian tribes in Wisconsin have an interest in any catalogued burial site throughout the state. They also approve transfers of burial sites from municipal jurisdictions to private individu-

Burke felt a local connection between the board and the Oneida community would increase the communication level on the state, tribal and federal level. "I accepted this position because it is so important not to forget to take care of our ancestors. I respect our elders, youth, and children and do my best to take care of them while we are living but make sure not to forget to take care of them while they are resting," said Burke. "I feel that I could be a good asset to assure no disruption, removal, or desecration of all our ancestors."

Burke's 14 years of experience at the local and federal level prompted her nomination by the Wisconsin Intertribal Repatriation Committee and state of Wisconsin representatives.

"The basis of my job is to make sure that Federal, State, Local, and Governments stay in compliance with the Federal Historic Preservation Law. I monitor, assess, and determine if any earth moving projects will affect our cultural, traditional, and burial sites, if so, then it is my job to ensure other alternatives within a project to the best of my ability,"

Burke said of her present job

with the tribe.

Burke's responsibilities on the board do vary much from her current position. "The role of my responsibilities on this board will be on a feder-

- Co-organized the successful effort to stop the Milwaukee Circus Parade from using the State of Wisconsin Historical

Society Pawnee Bill Circus Wagon which depicted Columbus planting his flag on our land on one side of the wagon and Pocahantes fending off savage killing Indians from killing John Smith on the other.


- Participated with the Midwest Treaty Network from Madison, WI, four straight years at Lac du Flambeau during their spear fishing season boat landing controversy, the first two years I ran their office.

  - Served on and I'm also running for: Oneida Nation Commission of Aging, at one point as vice chair. **Land Commission Land Claims**



This list is just some of the changes accomplished during my term. Other changes affecting how we think about our role and responsibility in tribal government, whether we are elected or appointed officials, managers, or employees, are less visible. The differences between governing and managing must be clear to us. Being a member of the BC is to govern.

To set direction, make decisions about what the

tribe will do and to monitor performance, progress and results. Managers figure out how to implement a directive and to do so effectively and/or efficiently. The BC is often held accountable for services and performances that it knew little about.

I am running for re-election as the Tribal Secretary because I want to continue working to change Oneida government so it becomes more open, its leaders accountable, and to find ways to make it easier for tribal members to participate. This kind of change is possible when you have a Tribal Secretary who will strive to serve all tribal members, regardless of what side of an issue you are on. The Tribal Secretary's Office is the hub of government because much of the information about what our tribal government does is produced or maintained in here. It is critical that tribal members are confident that their Tribal Secretary will serve with integrity, trust and professionalism.

As Tribal Secretary, I'll continue working for change. I'll continue questioning the status quo to help our government become more accountable. I'll work for reform of rules and laws to create more open government and checks and balances. It has been said that a political race by its very nature means candidates disagreeing with each other about a range of issues. Nevertheless, there is one thing we can all agree on: the people of the Oneida Nation deserve a strong voice that represents all of us, not just the well connected few.

We all know how important it is to protect the unique and special place we call home. I think we can all agree on - that we are facing some serious challenges; for example, the attack on the Nation's sovereign right to exist is a serious concern. The village of Hobart has challenged our right to exert our Sovereignty on the Oneida Reservation. Most recently, the Village of Hobart has challenged us in court with regard to the status of our land located within the original boundaries of the reservation. We must be forever diligent in protecting the Nation from outside forces; we must be prepared to meet these challenges head on. I would propose a collective strategy utilizing the expertise of the many Indian Nations located throughout the country. Our leadership, needs to be experienced enough to guide the nation through finding real solutions to these challenges, and to embrace new and innovative ways solving our problems.

**Leadership:** the elected leaders of the Oneida Nation are not considered Traditional Chiefs however; the traditional values of leadership are a mainstay in the core values of basic beliefs of Iroquois people. It is my belief that the basis of good leadership is honorable character and selfless service to the nation and the organization.

State of the Nation: I propose the Oneida Business Committee conduct a six-month review/analysis of the nation's organizational structure. I would propose to address the nation's future by preparing a status report on the state of the nation. As a nation, it is imperative that we work together and place an emphasis on communicating so that we reexamine structure and make changes to benefit the nation.

Accountability: I support the need for accountability. Accountability means building a strong nation with an organizational structure committed to the highest standards, it requires more than just following laws. It also requires fostering practices that create an environment of transparency, accountability, and integrity. Accountability reassures its members/employees of its commitment to upholding the public trust vital to earning trust, and respect, in fulfilling the nation's mission. Enhancing the nation's current laws and policies can do this. I believe and support the concept of leading by example.

**Employment:** Employment for all tribal members is a priority. I support the employment of tribal members and the upward mobility of tribal member employees within the organizational structure of the nation. I support the need to have qualified tribal members in key management positions. The nation needs to assist and provide innovative ways to ensure tribal members have an opportunity to become qualified to better serve the nation.

**Social Services:** I support the need to improve the social services of the nation, and to work in meeting the unmet needs of the nation in this area. For example, we need to improve the quality of life for those afflicted with alcohol and drug problems by providing opportunities for wellness we need to evaluate and access the need for a halfway house. Children in need and at risk need a safe environment I support the need for a group home for our children.

Healthcare: I support the need for additional health care dollars to improve the delivery of health care services and additional dollars to increase the staffing levels of the health center.

**Elders:** I support the need to provide additional dollars to improve the delivery of services to our elderly. I support the elderly assisted living project. I support the efforts of the Oneida Nation Commission on Aging in addressing the long-term care options for elderly members of the nation.

## **Another Perspective**

This is to address some of the comments that recently appeared in the columns of three of our Business Committee Leaders in reference to the StrateGlobe contract on performance management, and to clarify some of the misrepresentations.

A need for a performance management system was identified by the HR manager and some of our forward thinking leaders, in direct response to many of the GTC comments to address the perceived internal waste of the operations. StrateGlobe was asked to submit a bid, not only to establish a performance management system, but also to help with the implementation phase (this is where there can easily be a breakdown in our work from external consultants). It included identifying three software platforms (for the Tribe's final determination); and the training that would be needed for the implementation in a very tight schedule (9 months to train ALL 3000+ employees - a \$250,000 direct expense).

Additionally, it included large direct expenses, such as flying in representatives from organizations and companies to share their challenges on moving toward performance excellence. It was established early on that if the training could be provided in-house, that would reduce the contract cost by that amount. This gives an opportunity for the Tribe to do as much work internally to minimize the cost.

Therefore, the suggestion that the total value of the contract would be one-person's fees, is as misleading as assuming that our gross revenue (intake/drop) from gaming is the Tribe's amount to spend. Consideration needs to be given to the direct expenses associated with gaming -- i.e. payouts as regulated by compact, and operational expenses.

However, let's not lose sight of the issue at hand. If we assume that we do NOT need a performance management system, then we must indisputably believe that presently our operation provides the highest quality of service; the best place to work for our employees (a positive environment); the best processes for continuous improvement; and the best systems in place to provide the best return on financial performance across all divisions.

The performance management project was designed to provide a connection to "best of class" practices to enhance execution that would promote economic development and high quality of life through organizational excellence. The project had merit in being a "first" in Indian Country with an integrated system of excellence (those "firsts" that are recognized by the Harvard Project throughout Indian Country). The project had the opportunity to bring best performing companies to Oneida to dialogue on the challenges and successes of a journey toward performance excellence - to showcase first-hand a sovereign Nation and its culture.

The sole-sourcing went through the normal channels that are set up by the Tribe. This is not the first contract to be sole-sourced, nor do I believe that it will be the last contract sole-sourced. All BC members should have as leaders a responsibility to be attuned throughout their terms

to the projects that can impact the Tribe's operations. As for StrateGlobe LLC, it is a business consulting firm, established in Missouri, and with a presence in Oneida, Wisconsin. It is denoted as a small business, 100% woman-owned, Native American (Oneida) firm. It has been awarded its Federal 8(a) and Wisconsin DOT/DBE

## The firm's work involves both domestic and international arenas and specializes in:

- Identifying new revenue markets and customer bases;
- Designing new systems and processes that support organizational performance;
- Planning for integrated supply chains;
- Training for workforce development in order to capture new opportunities and operational efficiencies with "best of class" practices.
- Establishing new markets with a concentration on Latin America

As for myself as the principal of this practice, I bring a background with multinationals in assessing new revenue streams; creating and implementing expansion plans for start up business units; developing international marketing plans; and benchmarking best of class practices. 

Try living without water for a day. Bet you can't. Even if you don't drink it, water was used to grow the food you eat and the cotton that your clothes are made of, in energy production, and even in the production of your car (32,000 gallons of water for just the steel of one car).

The Great Lakes Water Compact, which Wisconsin recently signed, states that the waters of the Great Lakes Basin are precious, public, interconnected, serve many uses, and of vital importance. All of us living in the Great Lakes Basin already knew all of that. However, the last finding is something that we all often forget; that we all share the duty to protect, conserve, restore, improve, and manage our waters.


I often assume that everyone knows how to protect

## Where's the fry bread?

Hope everyone had a good time at the family carnival last weekend! I was helping a friend with her food stand that featured indigenous foods and we were continuously asked "Where's the fry bread?" Certainly that's Indian! Is it? We all love to eat it but did Oneidas eat fry bread pre-colonization? No. Traditionally Oneidas ate wild game like deer, corn, beans, squash, berries, and wild herbs and roots. Oneidas learned to plant oats and wheat from neighboring farmers in New York. The removal of Oneidas


from the homelands in New York to Wisconsin began in 1823 and lasted until 1841. The family groups that came brought many seeds but were unable to plant their first year. They simply did not have time to clear the forest and build a home and plant crops. It was then that they addressed the United States Department of

called) to "send food as promised. Our children and wives are starving." (according to Loretta Metoxen at Cultural Heritage). It was then that the US government sent flour, peas, beans, and rice. Not too tasty eh? Amazingly, out of this was born "fry bread".

What were once lean, fit examples of health became overweight, some obese, with chronic conditions like diabetes and heart disease. How are they related? Well most people don't know that diabetes does not come from eating sugar. Research suggests that an increased risk of diabetes is directly linked to the amount of body fat one has in addition to lifestyle behaviors such as inactivity.

Our ancestors worked all their lives. They had to hunt and grow or forage for food. They had to make their own dishes and wash them. They

So what's fry bread? Well, first let's start with the flour. It's degerminated (this is where the germ-the nutritious part-has been removed) and most likely bleached. The USDA's Recommended Daily Allowance (RDA) recommends that one half of all grains consumed be whole grains. Next it's made by deep frying it. Now it's laden with fat. So what can we do about this? Certainly I'm not suggesting you stop eating fry bread....but you could share one piece instead of having several. Try some healthier foods like wild rice or corn soup. And let's not forget, our ancestors were fit because their lives were work. Imagine not having a dishwasher or washing machine. How would you like to haul water from the creek? All of these had to be done by hand. So try going for a walk or plant a garden. You'll get some exercise, fresh

## **BBBS** rolls out new summer fun

Playing football in the park, working on that perfect golf stroke and attending professional sporting events are just a few ways that you could impact the life of a child from Oneida.

Big Brothers Big Sisters is pleased to announce the kickoff of their new Sports Buddies program geared towards matching Big Brothers to Little Brothers. Whether it is training for the upcoming season, or watching the professionals play, Sports Buddies Bigs and Littles meet at least twice a month to participate in a sports-related activity. Big Brothers Big Sisters sponsors two events each month, ranging from watching Bullfrogs games to participating in weight lifting, and everything in between. All tickets and equipment are supplied; all you need is the desire to make an impact on the life of a youth in your community. For a six month minimum commitment, you could help reduce school truancy and drug use while making a positive impact on the world.

"We have seen a significant increase in the amount of youth from Oneida signing up for the Big Brothers Big Sisters program. Currently there are 13 children eagerly looking for a Big Brother, Big Sister or Big Couple to spend time with. The majority of these are Little Brothers. These children tend to wait for a Big longer since there are not as many volunteers signing up for the program from the Oneida area. We are hoping the word will spread throughout the community so we can get all 13 youth paired with a mentor by the end of the summer," states Sara Karcz, marketing and partnership coordinator with Big

Brothers Big Sisters. For those volunteers not interested in sports, there is traditional the Community-based Program where Bigs meet with their Littles weekly and do everyday activities in the community. To volunteer for either program, applicants must be at least 16 years of age. (There is no age limit.) Big Brothers Big Sisters screens each volunteer by doing background checks, reference checks and conducting an interview. The professionals at Big Brothers Big Sisters ensure that going through the enrollment process is convenient to fit the volunteers' needs. After being matched with a Little Brother or Little Sister, a match support specialist will call once a month to check in and see how things are going. Volunteer training is offered on an ongoing basis.

It doesn't take a professional athlete to be a "Big" Sports Buddy, or a child expert to be a communitybased "Big", it simply requires a big heart and the ability to be a friend. Being a "Big" is about sharing simple, magical moments with a child to help open their doors and widen their horizons. Your life doesn't need to drastically change to have a huge impact on a child's life.



## Art museums deal with attendance issues

MILWAUKEE (AP) ~ In the Milwaukee Art Museum world, 2008 is seven years A.C. - or After Calatrava.

That is, seven years after the grand white addition with its glass ceiling and moveable sunscreen designed Spanish architect Santiago Calatrava opened Milwaukee's lakefront - his first completed project in the United States. It has helped pull the museum out of \$30 million in debt, increased attendance and attracted acclaimed exhibits.

Now, with the novelty wearing off, the museum must determine a new path.

And it's doing it with new director Dan Keegan, who spent the past seven years at the San Jose Museum of Art in California's Silicon Valley.

Many museums are in a similar situation. A 2006 survey by the American Association of Museums found that 50 percent of responding museums had begun or completed construction, renovation or expansion in the previous three years.

"I think in my personal opinion this notion of new that museums have latched onto could be a trap in a way," said Kathleen McLean, president of the Visitors Study Association. "It's not necessarily that people need some-

thing new, it's more about looking for nourishment however you define nourishment and satisfaction."

It's hard to know exactly how expanded museums are doing because 35 percent of museums are free and some museums count visitors differently, AAM spokesman Dewey Blanton said. Some may not be able to sustain the initial spike, but have increased attendance compared to before the expansion or renovation. Such is the case with the Milwaukee Art Museum.

Attendance was up in 2007 nearly 80 percent from 2000 \_ the year before the addition opened \_ but down about 45 percent from the year after the addition opened. Officials there consider themselves successful. They increased attendance overall and are fulfilling the promise of the addition: Expect the unexpected.

"It's maybe more of a sculpture than it is a building. It's kinetic and moveable and Keegan said. dynamic," "Those things say again to expect the unexpected and I think that's the opportunity for us as we think through the programming, the exhibits, the educational experience, the visitor experience."

But along with the candidates, we, the voters must have integrity as well. We have to ask ourselves is a candidate speaking the truth, or he/she saying what we want to

hear?

Is the candidate making promises he/she can keep? A candidate can promise us more

per capita while cutting the budget, but can he/she deliver both items?

Is the candidate acting in a responsible manner? There are a few candidates and their supporters willing to exploit people's anger and fear by spreading false or misleading information. That information needs to be questioned. Moreover, the ones spreading the information need to be asked why they are lying to their people. A candidate may accuse others of acting in a dishonest manner, that doesn't make the accuser innocent of the same behav-

Most importantly, we have to ask ourselves are we voting for someone for the good of ourselves or the good of the tribe.

In this time of economic uncertainty, it would be easy to look out for our own interests and vote for the candidates that promise pie in the sky and a gallon of gas in every tank. It's much harder to pick someone who is planning for the future, who is willing to forgo quick fixes to get elected.

We the voters have a lot of choices to make. The people we put in office now will have an impact beyond their three year term and our reservation boundaries. Choose wisely.

Provide a True Cost of Living Adjustment for our Employees I authored the original petition which led to the original wage study and I'm currently working to ensure that the Valiant wage study is implemented fairly. Likewise, I'm convinced that we can pay all the Oneida employee's a good living wage while having some boundaries around high wages.

**Increasing the limit for our Educational Funding** 

It has been twenty years since this program was implemented to provide funds to assist our membership in attending school. It is time to increase the funding limits, I have a plan designed which calls for a tiered funding system.

**Building More Affordable Homes** 

There is no real reason why we only seem to squeeze out a few homes each year with our federal allocation, I find it unacceptable. We get well over \$3 million a year and we must do more. I have offered some ideas to leverage our dollars and to accelerate the pace at which we build homes. There are many tribal members that would like to own their own home and we must see that happen. My proposal is to partner with other tribes to build environmentally friendly log homes utilizing solar and wind powered energy sources.

Placement of Cameras to broadcast Business Committee Meetings This will allow our membership to access the meetings and will provide greater open government. Recent developments have highlighted the need to have increased scrutiny to avoid ill conceived political activities.

Financial Support for Small Business Development I authored the Project 2000 Small Business Initiative. We need to keep investing in the Oneida small business sector.

**Long-Term Per-Capita Solution** 

I've authored a unique "Oneida Per-Capita Plan Plus" which is designed to enhance and augment the retirement of Oneida Tribal members for generations to come. This is a plan I authored as a response for the need to have a long-range plan in place. The plan is designed to sustain the tribe's per-capita payments for future generations without the continued reliance on a direct tribal funding source.

**Increase in The Burial Fund Limits to Cover Costs of Funerals** Currently, the Burial Fund does not cover all the costs of funerals and there is a need to keep pace with the costs of inflation.





#### Abuse of power

In January of 2008, the Oneida Housing Authority decided that the Oneida Tribal members should have to calculate the December 2007 \$5000/\$10,000 per capita payment into their annual income. This caused payments from the tribal members to the Oneida Housing Authority (OHA) to go up.

Research by Councilman Ed Delgado proved that OHA did not have to include the special one time per capita. On May 14, 20087 Ed Delgado submitted a resolution before the Oneida Business Committee to overturn the OHA ruling. There were six Business Committee members present: Ed Delgado, Vince DelaRosa and Secretary Patty Hoeft voted to overturn OHA. Vice Chair Kathy Hughes and Treasurer Mercie Danforth voted not to. Why did Hughes and Danforth vote no? Was it to punish the tribal members for getting a substantial per capita? I wish they would explain their actions!

In an odd twist, Oneida General Manager Debbie Thundercloud, Kathy Hughes and Mercie Danforth signed off on a contract that was given to a tribal member for \$575,000 without notifying whole **Business** Committee. Is this legal? It doesn't seem like it should

The project was incorrectly identified in the article.

2. The contract for the Oneida Nation Walk of Legends is a "name sponsorship" contract.

The contract type was misrepresented by the author of the article.

3. The creator and owner of the Walk of Legends in concept, design, content and proprietary methods of installation and construction is a private company and, as such, protection of its proprietary and intellectual capital is provided for under federal laws governing the use of copyright and trademarks.

The creator, owner and rights holder of the Walk of Legends was misrepresented and misappropriated by the author of the article.

creator/owner/ rights holder of the Walk of Legends, a private company, bears the responsibility for securing competitive bids for this and other projects of which it implements and is the author and creator.

The party responsible for securing competitive bids and hiring contractors for this Walk of Legends was misappropriated and misrepresented by the author of the article.

5. Attorneys and all parties involved in the drafting, negotiating and execution of a binding name sponsorship contract for the Walk of Legends followed the letter of both Oneida Tribal law and policy and U.S. Government law.

of the All members Oneida Business Committee, including the author of the article were informed about the contract for name sponsorship for the Oneida Nation Walk of Legends, the scope and merits of the pro-

An explanation of the scope and merits of the Walk of Legends name sponsorship was also provided to tribal managers and tribal membership at General Tribal Council meetings.

Non-fact based statements about the intent of those involved in the process of securing, drafting, negotiating and executing the name sponsorship contract and non-fact based statements about how procedures were followed in that process were conveyed and published without independent verification by the author in the article.

6. The author of the June 5, 2008 Secretary's Report, failed to state, as a preface to the article, that the opinions contained therein were those of the author and, as such, not necessarily based on fact, nor were they necessarily representative of the opinions held by a majority of the tribal membership, its directors, tribal leadership or the staff or editors of the Kalihwisaks newspaper.

7. In outlining a campaign platform of "transparency in government," the author of the June 5, 2008 Secretary's Report failed to disclose the author is an incumbent candidate seeking re-election to the post of tribal secretary and, further, that the space used in this Secretary's Report to outline an election campaign platform was not paid for by the author.







## LEADERSHIP

I've been blessed by knowing Indian leaders whom I feel were throwbacks to our history as Indian people. They, many now gone, never considered their personal interests and wealth above the well-being of the people. These were leaders the people could depend on. They made decisions that served the elderly, the ill, and the children who came first and above all else. Today, leadership responsibilities have increased. Oneidas need fair employment and educational opportunities; affordable housing; quality health care; and our veterans deserve the continued benefits and recognition they earned while in the service of their country.

## SOVEREIGNTY

In April the Tribe's sovereignty was diminished by a Federal court ruling which allowed the Village of Hobart to condemn (take) Tribal land. Another judge with a law degree unable to read an Indian treaty. The Federal decision was one of many over the years which increasingly pose a threat to the inherent right of Indian tribes to govern themselves. Yet, as Federal courts grant states authority over our people, Indian children are still 2 times more likely to be physically, sexually and emotionally abused, Indian women are 3 times more likely to be physically and sexually assaulted, and the lives of many Indian youth continue to be

destroyed in the punishment dominated meat grinding court systems which surround many Indian communities, including Oneida. I believe the Oneida Tribe needs to protect its sovereignty by establishing a strong and accountable government. Fundamental components of a strong government are its leadership, laws and courts. If elected, I'll continue to provide knowledgeable and hard working leadership needed to make decisions that are in the best interest of the people and to protect our sovereignty as an Indian nation.

## OHA RENT AND MORTGAGE RECALCULATIONS

Soon after the membership received the recent \$5,000 / \$10,000 per capita payments last December, Oneida Housing Authority residents began receiving notices that their rents and mortgages were being raised because of the payment. The increases created a hardship and people contacted my office for help. In response, I researched Federal regulations and found that the special one-time per capita payment did not have to result in higher rents and mortgages. When I first communicated my findings at the Business Committee level, Tribal "experts" vigorously disagreed with my findings. Soon after, a Tribal elder received notification from a Federal housing official that indeed the one-time payment did not have to result in higher rents and mortgages (our elders don't give up). In response, my Legislative Assistant and I drafted a resolution to stop OHA from increasing rents and mortgages based on the onetime per capita payment. That resolution was approved by the Business Committee in April. I am told that as a result of the Resolution, hundreds of Oneida families have had, or are in the process of having, their rents and mortgage payments reduced.

## TRIBAL EMPLOYEE WAGES

Throughout my first term, I've worked for fair wages and fair working conditions for Oneida Tribal employees. I believe Tribal employee wages should keep up with inflation (COLA) and I believe that wages should also recognize years of experience and work initiative. If elected, I'll continue to help Tribal employees. In addition, I find the recent Valiant Wage Compensation initiative to be very disappointing and if elected, I'll work to revise it. At a minimum, Tribal wages need to keep up with inflation and that assurance has to be placed in the 2009 budget.

## Financial Information & General Tribal Council Revitalization

The Oneida Constitution places the powers of government under the authority of the General Tribal Council (the people). The By-laws say that the Council must, at least twice a year, receive a report on "all receipts and expenditures and the amount and nature of all funds" at all regular meetings of the Council. As the years have passed, I believe that the spirit of our Constitution and By-laws has increasingly been diminished. As a result, the General Tribal Council over the years has increasingly lost its authority over and right to financial information. Then came the John Powless petition of 2007.

The 2007 decision of the General Tribal Council to pay the membership \$100 for attending GTC meetings has resulted in the Oneida people gathering by the hundreds to make the important decisions of the Tribe. I believe a new direction has been set. I further believe the new direction is consistent with what our ancestors intended more than 60 years ago, a nation governed by the people.

## For Your Information

Starting February 2009 television broadcasting will be changed from analog to digital. This is supposed to provide better viewing and help emergency responders protect the community. In order for this change to not affect your television viewing a TV converter box must be purchased and connected to your television. Most converter boxes will be priced from \$50 to \$70. Any televisions connected to cable, satellite, or services of the sort do not need a converter box to receive broadcasting.

Since new equipment must be purchased to accommodate the broadcasting change the government is offering a program to help lower the cost for consumers. You can apply for a \$40 coupon via telephone, online, mail in, or by fax. There is a limit of two coupons per household. The remaining balance of the converter will be the consumer's out of pocket cost. To get more
